
**BANKRUPTCY ORDER**

**UPON THE APPLICATION** of Laurentian Bank of Canada, a creditor, having an office in the City of Montreal, in the Province of Quebec, and upon reading the Application for Bankruptcy Order issued on November 27, 2020, the Affidavit of Verification sworn September 15, 2020, and the Consent of KSV Restructuring Inc. to act as trustee in bankruptcy, and it appearing to the Court that the following act of bankruptcy has been committed, namely, 2145744 Ontario Limited ("744") has ceased to meet its liabilities generally as they become due.

1. **THIS COURT ORDERS** that 744 be adjudged bankrupt.
2. **THIS COURT ORDERS** that KSV Restructuring Inc. be appointed as trustee of the estate of the bankrupt.

3. **THIS COURT ORDERS** that the trustee give security in cash or by bond or suretyship without delay in an amount to be fixed by the Official Receiver, in accordance with subsection 16(1) of the *Bankruptcy and Insolvency Act*.

4. **THIS COURT ORDERS** that the costs on a substantial indemnity basis of the application creditor in connection with this application be paid out of the estate of the bankrupt on taxation of the estate.
