Notice and Statement of Receiver (Subsection 245(1) and 246(1) of the *Bankruptcy and Insolvency Act*)

IN THE MATTER OF THE RECEIVERSHIP OF 1230172 ONTARIO INC.

- 1. On July 21, 2025, the Ontario Superior Court of Justice (the "Court") issued an order (the "Receivership Order") appointing KSV Restructuring Inc. ("KSV") as the receiver and manager (the "Receiver"), without security, of all the property, assets and undertakings (together, the "Property") of 1230172 Ontario Inc. (the "Company").
- 2. The Company owns real property located at 110 Central Park Dr, Ottawa (the "Real Property") which operates as a senior living home under the name "Park Place Retirement Residence".
- 3. The application to appoint KSV as Receiver was made by Cameron Stephens Mortgage Capital Ltd. ("Cameron Stephens"), the Company's principal secured creditor.
- 4. Based on the most current financial information available.¹, which is dated December 31, 2024, the approximate book values of the Company's assets are as follows:

6. Secured Creditors

Based on the application materials for the Receivership Order, the Company's principal known secured creditor is Cameron Stephens who was owed approximately \$12,520,831 as at March 13, 2025, secured by a first mortgage on the Real Property.

7. Unsecured Creditors

Based on the Company's books and records, the Company's unsecured creditors as of July 21, 2025, were owed approximately \$407,000. All known unsecured creditors as at the date of the receivership are listed in Appendix "A".

8. Estimated Realization and Sale Process

The Receiver intends for the Park Place Retirement Residence to continue to operate in the normal course during these proceedings while a Court-approved sale process is carried out by N.R.E. Newmark Real Estate Canada Limited under the supervision of the Receiver. The outcome of the sale process will determine whether there are any funds available for distribution to unsecured creditors.
