#### EXTENSION OF TIME TO FILE A PROPOSAL

- 2. **THIS COURT ORDERS** that pursuant to Section 50.4(9) of the BIA, the period for the Debtor to file a proposal to its creditors under the BIA be hereby extended for a period of 45 days from September 24, 2022, to and including November 8, 2022.
- 3. THIS COURT HEREBY REQUESTS the aid and recognition of any court, tribunal, regulatory or administrative body having jurisdiction in Canada or in the United States to give effect to this Order and to assist the Interim Receiver (or any successor receiver) and its agents in carrying out the terms of this Order. All courts, tribunals, regulatory and administrative bodies are hereby respectfully requested to make such orders and to provide such assistance to the Interim Receiver (or any successor receiver), as an officer of this Court, as may be necessary or desirable to give effect to this Order or to assist the Interim Receiver (or any successor receiver) and its agents in carrying out the terms of this Order.
