SUPPLEMENT TO THE FIRST REPORT OF KSV RESTRUCTURING INC. AS RECEIVER AND MANAGER

OCTOBER 26, 2022

1.0 Introduction

- 1. This report (the "Supplemental Report") supplements the Receiver's First Report to Court dated October 20, 2022 (the "First Report").
- 2. Unless otherwise stated, capitalized terms used in this report have the meanings provided to them in the First Report.

1.1 Restrictions

1. This Supplemental Report is subject to the restrictions in the First Report.

2.0 Leased Equipment

1. Since the filing of the First Report on October 20, 2022, a number of developments have occurred with respect to the various lessors of equipment to Allied. These developments are described below.

2.1 Calmont Leasing Ltd.

1. The Receiver corresponded with Calmont regarding a potential buyout of the Calmont lease. As of the date of this Supplemental Report, Calmont has not responded. The Receiver will continue to follow up, and if a buyout at an acceptable price is not possible, the Receiver will return the Calmont Units to Calmont, as proposed in the First Report.

2.2 Caterpillar Financial Services Limited

- The Receiver has corresponded with Caterpillar regarding a buyout of its lease. The
 Receiver intends to buy out the Caterpillar lease and the Auctioneer has agreed to
 increase the Guaranteed Amount by the amount proposed by Caterpillar. The
 Caterpillar Unit will therefore be included in the auction contemplated by the ASA.
- 2. The Receiver intends to formalize the buyout of the Caterpillar Unit and include the Caterpillar Unit in the "Assets" to be sold pursuant to the ASA. The Caterpillar Unit has accordingly been included in Schedule "A" to the draft order sought by the Receiver, and a blackline of the draft order against the version that was served by the Receiver with the First Report is attached hereto as Appendix "A" (the "Order"). The Receiver will not sell the Caterpillar Unit until the buyout has been formalized, or until Caterpillar consents.

2.3 Danella Rental Systems Ltd.

- 1. The Receiver was contacted by Goodmans LLP ("Goodmans") on October 24, 2022 and advised that it was in the process of being retained by Danella.
- 2. As set out in the First Report, the Receiver has concluded that the Danella Units were leased by Old Allied pursuant to a financing lease of a term of more than one year and that Danella's deemed security interest is not perfected because Danella did not register against Old Allied or Allied under any personal property security registry. The Receiver notified Danella of this position by letter dated October 12, 2022.
- 3. Danella has not advised the Receiver of its position regarding the relief being sought in the Receiver's motion.

2.4 Falcon Equipment Ltd. and Valiant Financial Services Inc.

1. The Receiver has reached out to Valiant to inquire about a buyout of the Valiant lease. Valiant responded and advised that its counsel will be in touch with the Receiver to discuss buyout options. As of the date of this Supplemental Report, the Receiver has not yet corresponded with Valiant's counsel.

- 2. As advised in the First Report, if an acceptable buyout amount can be negotiated, the Receiver intends to pursue that and sell the Valiant Units. If no such buyout is achievable, the Receiver intends to return the Valiant Units to Valiant.
- 3. The Valiant Units have been added to the Order. The Receiver will not sell the Valiant Units until the buyout has been formalized, or until Valiant consents.

2.5 Meridian OneCap Credit Corp.

- 1. The Receiver has inquired with Meridian regarding a buyout of the Meridian lease. As of the date of this Supplemental Report, no response has been received.
- 2. The Meridian lease includes an early purchase option, effective as of 25 months after the August 17, 2021 commencement date of the lease, which the Receiver intends to exercise. The Receiver will continue to follow up with Meridian.
- 3. As reported in the First Report, anticipating that a buyout will be completed, the Meridian Unit is listed in Schedule "A" of the ASA, as an asset to be sold.
- 4. The Meridian Unit has been added to the Order. The Receiver will not sell the Meridian Unit until the buyout has been formalized, or until Meridian consents.

2.6 Quip Finance and Vault Credit Corporation

- 1. The Receiver has inquired with representatives of Vault in respect of a buyout of the Vault Unit. Vault is prepared to accept a buyout at an amount that the Auctioneer is willing to match by an increase to the Guaranteed Amount if the Vault Unit is included in the auction contemplated by the ASA.
- 2. The Receiver intends to formalize the buyout of the Vault Unit and include the Vault Unit in the "Assets" to be sold pursuant to the ASA. The Vault Unit has accordingly been included in Schedule "A" to the draft order sought by the Receiver. The Receiver will not sell the Vault Unit until the buyout has been formalized, or until Vault consents.

2.7 Wheaton Chevrolet Buick Cadillac GMC Ltd.

- 1. The Receiver's counsel contacted Wheaton on October 20, 2022 to inquire whether Wheaton would agree to a buyout of the Wheaton lease. On a subsequent phone call the next day, a representative of Wheaton advised the Receiver's counsel that Wheaton required that the Wheaton Unit be returned immediately and once in possession, it would consider the terms of a potential buyout.
- Wheaton was advised by the Receiver's counsel that the Receiver would not be returning the Wheaton Unit until after the Receiver's motion on October 28, 2022, including because Allied's stakeholders may object to the return of the Wheaton Unit that was proposed in the First Report. The Receiver's counsel confirmed this position in writing, by email on the same day.

- 3. On the evening of October 21, 2022, the Receiver was notified by an employee of Allied that Wheaton had contacted him and indicated that agents of Wheaton were on their way to retrieve the Wheaton Unit. In response to this information, the Receiver's counsel sent a second email to the Wheaton representative, attaching the Appointment Order, and reiterating the Receiver's position that the Wheaton Unit would not be returned until after the October 28, 2022 hearing. This email included the following:
 - "...if Wheaton attempts to seize or repossess the Denali, it will be in breach of the attached order and in contempt of Court. If what we have heard is correct, and representatives of Wheaton are on their way to seize the vehicle, I would encourage you to contact them and tell them to stop, immediately. Should you choose to take action in breach of the attached Court order, the Receiver reserves all of its rights against Wheaton."
- 4. Notwithstanding the objections of the Receiver, on Monday, October 24, 2022, the Receiver learned from Allied that Wheaton representatives attended at the property of the Allied representative, without permission, and took possession of the Wheaton Unit on October 21, 2022. The Receiver was advised by the Allied employee that he spoke to Dave Wheaton, the owner of Wheaton, who informed him that if the Wheaton Unit was not surrendered to Wheaton, it would be towed.
- 5. On October 24, 2022, the Receiver's counsel wrote to Wheaton to express the Receiver's objection to the seizure of the Wheaton Unit and reserve all rights against Wheaton. A copy of this letter, which attaches the two October 21, 2022 emails from the Receiver's counsel, is provided as Appendix "B".
- 6. In the Receiver's view, Wheaton and Mr. Wheaton are in breach of the stay of proceedings in the Appointment Order, which they knowingly and intentionally violated. The Receiver may seek relief as against Wheaton or Mr. Wheaton at a later date and reserves all of its rights to do so, including claims for damages and costs incurred as a result of Wheaton's breach of the Appointment Order.

2.8 Queenston Chevrolet Buick GMC and Setay Motors Inc.

- The Receiver has been in contact with representatives of Setay and is discussing a
 potential buyout of the leases related to the VIN Registered Setay Units. As of the
 date of this Supplemental Report, terms for a buyout have not been agreed by the
 parties.
- 2. The Receiver understands from Setay that it does not object to the relief sought by the Receiver to sell the Unregistered Setay Units.

2.9 LMS Rail Services Limited

1. As detailed in the First Report, the Receiver has been in contact with LMS since September 9, 2022 regarding LMS's unperfected deemed security interest and has been corresponding with LMS's counsel since October 14, 2022.

- 2. Subsequent to the filing of the First Report, the Receiver was provided with an email update on October 21, 2022 by LMS's counsel regarding the LMS Units. The following is based on the information provided in that email. The Receiver's position with respect to the LMS Units, as outlined in the First Report, is unchanged from the First Report, except that the Receiver is satisfied that two of the LMS Units ought to be returned to LMS because they are not subject to a lease of a term of more than one year.
- 3. The Receiver has updated the chart summary attached as Appendix "I" to the First Report to reflect the information provided by LMS, and information confirmed by the Receiver pursuant to updated searches against the LMS Unit VINs. This updated chart summary is attached as Appendix "C".

New Master Lease & Lease Schedules

- 4. LMS provided a copy of an equipment master lease dated March 22, 2021 between Allied and LMS, which appears to have been entered into prior to the purchase of Old Allied's assets by Allied on April 30, 2021 (the "March 22 Master Lease"). The March 22 Master Lease includes an "entire agreement" provision and appears to be intended to be the governing document between Allied and LMS, superseding the August 1, 2016 master lease between Old Allied and LMS, attached to the First Report as Appendix "G" (the "August 1 Master Lease"). The Receiver had previously understood that the August 1 Master Lease had been assigned by Old Allied to Allied. A copy of the March 22 Master Lease is attached as Appendix "D".
- 5. LMS also provided 22 documents marked as "Schedule 'B' Equipment Lease Agreement", dated between May 27, 2019 and May 27, 2022 documenting the leases of particular LMS Units (collectively, the "Schedule Bs"). Neither the March 22 Master Lease nor the August 1 Master Lease refers to a "Schedule B". LMS has not provided the "Schedule A", which is referenced in the March 22 Master Lease. The Schedule Bs are attached hereto as Appendix "E".
- 6. The Schedule Bs include 21 LMS Units that are in Allied's possession. One of the Schedule Bs relates to a unit that was returned by Allied to LMS prior to filing the NOI (Ford F-350 Crewcab, VIN 1FT8W3B68KEG81843).
- 7. The documentation in respect of the LMS Units is unclear. The March 22 Master Lease was executed before Allied purchased the assets of Old Allied, but it is executed in the name of "Allied Track Services Corp.", by an employee of Old Allied who subsequently became an employee of Allied. The amended and restated asset purchase agreement between Old Allied and Allied pursuant to which Old Allied's assets were transferred to Allied does not explicitly list any LMS leases as "Material Contracts", and it is not clear whether Allied designated any LMS lease as an "Assigned Contract". The March 17, 2021 "Agreement" attached to the First Report as Appendix "G" explicitly consents to the assignment of the August 1 Master Lease by Old Allied to Allied.

8. Regardless of whether the March 22 Master Lease between Allied and LMS governs the LMS Units, or whether the August 1 Master Lease between Old Allied and LMS was assigned by Old Allied to Allied on April 30, 2021 and governs the LMS Units, the Receiver's conclusion with respect to LMS's entitlement to the LMS Units is the same: LMS does not have priority to the LMS Units and they should be sold. Moreover, despite the fact that the reference to "Schedule B" on the Schedule Bs does not correlate with either master lease, each of the Schedule Bs identify the LMS Unit to which they apply, and each is signed by Allied, and so the Receiver considers them to be binding leases on Allied (either as direct lessor, or as lessor by assignment).

Short Term Leases

- 9. LMS has advised that based on the Schedule Bs, two of the LMS Units are not subject to a lease of a term of more than one year: one 2015 Ford F350 Superduty (VIN 1FT8W3B63FEC59789) and one 2016 Ford F-350 (VIN 1FT8W3B61GED34605) (collectively, the "Short Term LMS Units"). LMS has formally requested the return of the Short Term LMS Units.
- 10. Based on the Receiver's review of the Schedule Bs, and the Receiver's consultations with Allied employees, it is satisfied that: (a) notwithstanding that the Short Term LMS Units are leased pursuant to a master lease of a term of more than one year, each is subject to a scheduled term of less than one year; (b) the Short Term LMS Units have not been in Allied's possession for more than one year; and (c) the Short Term LMS Units were intended to be returned to Allied after having been leased for less than one year.
- 11. Accordingly, the Receiver is satisfied that the two Short Term LMS Units are not subject to a deemed security interest under the OPPSA and should be returned to LMS. The Receiver has amended the Order to include authorization to return the two Short Term LMS Units.

LMS Secured Creditor Payouts

- 12. LMS advised that some of the LMS Units in respect of which LMS Secured Creditors have registered against VINs are no longer subject to a security interest in favour of those LMS Secured Creditors. LMS advised that:
 - a) Vic Lanoix Holdings Limited has been paid in full by LMS as of October 1, 2022, and therefore no longer has any valid security interests against the LMS Units;
 - b) HSBC Bank Canada has been paid in full in respect of 4 of the LMS Units against which it has registered; and
 - c) Meridian has been paid in full in respect of 4 of the LMS Units against which it has registered.

- 13. Based on updated searches against the LMS Unit VINs, the Receiver has confirmed that all registrations in favour of Vic Lanoix Holdings Limited have been discharged and four registrations in favour of HBSC Bank Canada have been discharged. The other VIN registrations by the LMS Secured Creditors are still registered against 19 of the 46 LMS Units. However, if the information provided by LMS is correct, it means that only 15 of the 46 LMS Units are subject to valid registrations by LMS Secured Creditors: HSBC Bank Canada (8 LMS Units), Meridian (4 LMS Units) and Caisse Populaire (3 LMS Units). This is a substantial decrease from the 41 LMS Units against which registrations have been made, as discussed in the First Report.
- 14. In the Receiver's view, the scope of the LMS Secured Creditors' registrations against the LMS Units is a matter for a subsequent distribution motion and will be independently confirmed with the LMS Secured Creditors and reported on in a subsequent report to Court.

LMS PPSA Registration

15. Based on the Ontario PPSA registry search results attached as Appendix "F", LMS registered against "2806401 Ontario Inc. o/a Allied Track Services Corp." on October 19, 2022, and amended that registration to amend the secured party name and add specific VINs, corresponding to the LMS Units, on October 21, 2022.

Receiver's Conclusions Regarding the LMS Units

- 16. The Receiver took the position in the First Report that LMS's deemed security interest in the LMS Units was unperfected as a result of its failure to register. The Receiver understands that LMS's regular business is to lease equipment, and therefore its unperfected status makes its interest in the LMS Units subordinate to the interests of Allied's other secured creditors. Now that LMS has registered, it may be perfected (subject to the reservation in paragraph 2.9.17), but as a result of the timing of that registration, it is still subordinate to the interests of Allied's other secured creditors, including Bridging.
- 17. Accordingly, the Receiver's recommendation with respect to the LMS Units is unchanged: for the reasons set out in the First Report, the LMS Units (other than the Short Term LMS Units) should be monetized by the Auctioneer and the proceeds should be separately recorded by the Receiver on a per-LMS Unit basis. The entitlement to the proceeds of sale of the LMS Units is a distribution matter, to be addressed at a subsequent distribution motion, at which Bridging, LMS and the LMS Secured Creditors may make submissions.
- 18. The Receiver has been advised by LMS's counsel that LMS does not intend to oppose the sale of the LMS Units (other than the Short Term LMS Units).
- 19. The Receiver notes the following regarding the LMS registrations, and reserves rights accordingly:
 - a) they were made after Allied filed the NOI. The Receiver reserves its right to take the position that this registration is therefore invalid. In the Receiver's view, this is an issue for a subsequent distribution motion, and the Receiver will make a recommendation to the Court in a subsequent report.

b) they were made against "2806401 Ontario Inc. o/a Allied Track Services Inc.", and do not show up on a PPSA search against "2806401 Ontario Inc." The Receiver reserves its right to take the position that the registration was not made in accordance with the OPPSA and associated Minister's Order.

LMS Secured Creditor Service and Contact Information

- 20. The Receiver has requested from LMS contact information for the account representatives at each of the LMS Secured Creditors. Contact information for individuals at Caisse Populaire and Meridian have been provided, and LMS has confirmed that Vic Lanoix and HSBC have received the Receiver's motion record. The Receiver has served or attempted to serve the LMS Secured Creditors with its motion record as follows:
 - a) Meridian: Served by email with the Receiver's notice of motion on October 19, 2022 and served by email with the Receiver's motion record on October 21, 2022. The Receiver will follow up with the individual contact information provided by LMS.
 - b) HSBC Bank Canada: Served by courier at the address listed in HSBC Bank Canada's registrations against the LMS Units, with delivery confirmed as of October 24, 2022 at 10:03 am.
 - c) Caisse Populaire: Served by courier at the address listed in the Caisse Populaire's registrations against the LMS Units, with delivery confirmed as of October 25, 2022 at 9:54 am. The Receiver will follow up with the individual contact information provided by LMS.
 - d) Vic Lanoix Holdings: The Receiver's courier has advised that Vic Lanoix Holdings cannot be located at the address listed in its registrations against the LMS Units. The Receiver confirmed through corporate searches that there was an error in the address in the Vic Lanoix registration, and has sent by courier its motion record to the address on the Vic Lanoix corporate profile report, which is expected to be delivered on October 26, 2022.

3.0 Recommendations

1. Based on the foregoing, the Receiver respectfully recommends that this Honourable Court make an order granting the relief set out in Section 1.1(1)(h) of the First Report, as amended by the revised draft order attached hereto as Appendix "A".

ORDER

(Approving Auction Services Agreement, and Ancillary Matters)

THIS MOTION made by KSV Restructuring Inc., ("KSV") in its capacity as receiver and manager (in such capacity, the "Receiver"), without security, of all of the assets, undertakings and properties of 2806401 Ontario Inc. o/a Allied Track Services (the "Debtor") for an order, among other things, approving the auction services agreement dated October 19, 2022 (the "ASA") between the Receiver and Corporate Assets Inc. (the "Auctioneer") to (i)

permit the Auctioneer to conduct a sale of the assets set out in the ASA, and (ii) vesting all right, title and interest of the Debtor in and to the assets described in Schedule "A" to this Order, and any assets of the Debtor that may be added to Schedule A of the ASA by the Receiver and the Auctioneer (the "Assets") to the purchasers as identified by the Auctioneer pursuant to the ASA, was heard this day by judicial videoconference via Zoom in Toronto, Ontario.

ON READING the First Report of KSV as Receiver dated October 19, 2022 (the "First Report"), the Supplement to the First Report of KSV as Receiver dated October 26, 2022 (the "Supplement") and on hearing the submissions of counsel for the Receiver, and those other counsel and parties listed on the Participant Information Form, no one else appearing although duly served as appears from the affidavit of service of [Nancy Thompson] sworn October [DATE]21, 2022,

SERVICE

1. **THIS COURT ORDERS** that the time for service of the Notice of Motion and the Motion is hereby abridged and validated so that this motion is properly returnable today and hereby dispenses with further service thereof.

APPROVAL AND VESTING

2. THIS COURT ORDERS AND DECLARES that the ASA and the transactions contemplated thereby are hereby approved, with such minor amendments as the Receiver and the Auctioneer may deem necessary and agree to in writing. Subject to the provisions of this Order, the Receiver is authorized and directed to take such additional steps and execute such additional documents as may be necessary or desirable to implement the ASA and the transactions contemplated therein.

- 3. **THIS COURT ORDERS** that subject to the terms of the ASA, the Auctioneer be and hereby is appointed as agent of the Debtor to sell the Assets.
- 4. **THIS COURT ORDERS** that, without limiting the generality of Paragraph 2, the Receiver and the Auctioneer are hereby authorized to sell, pursuant to the terms of the ASA, the Assets defined in the First Report as the LMS Units (other than the Short Term LMS Units, as defined in the Supplement), the Danella Units and the Unregistered Setay Units, which for greater certainty are scheduled as Assets to this Order.
- 5. THIS COURT ORDERS AND DECLARES that effective upon the delivery of a bill of sale by the Auctioneer to a purchaser (each, a "Purchaser"), any sale of the Assets set out in such bill of sale by the Auctioneer on behalf of the Debtor to a Purchaser shall be free and clear of and from any and all security interests (whether contractual, statutory or otherwise), hypothecs, mortgages, trusts or deemed trusts (whether contractual, statutory or otherwise), liens, executions, levies, charges or other financial or monetary claims, whether or not they have attached or been perfected, registered or filed and whether secured, unsecured or otherwise (collectively, the "Claims") including, without limiting the generality of the foregoing: (i) charges created by the order of Mr. Justice Osborne issued on September 23, 2022, and (ii) all charges, security interests or claims evidenced by registrations pursuant to the *Personal Property* Security Act (Ontario) or any other personal property registry system (all of the foregoing, collectively, "Encumbrances"), and for greater certainty, this Court orders that all of the Claims and Encumbrances affecting or relating to the Assets set out in such bill of sale shall be deemed expunged and discharged as against the Assets and that all of the Debtor's right, title and interest in and to the Assets shall vest absolutely in the applicable Purchaser.

6. THIS COURT ORDERS that for the purposes of determining the nature and priority of Claims, the net proceeds payable to the Receiver from the sale of the Assets (the "Net Proceeds") shall stand in the place and stead of the Assets, and that from and after the delivery of the bill of sale delivered by the Auctioneer to the Purchaser, all Claims and Encumbrances shall attach to the Net Proceeds from the sale of the Assets with the same priority as they had with respect to the Assets immediately prior to the sale as if the Assets had not been sold and remained in the possession or control of the person having that possession or control immediately prior to the sale.

7. **THIS COURT ORDERS** that, notwithstanding:

- (a) The pendency of these proceedings;
- Any applications for a bankruptcy order now or hereafter issued pursuant to the *Bankruptcy and Insolvency Act* (Canada) (the "**BIA**") in respect of the Debtor, any bankruptcy order issued pursuant to any such application, or any deemed assignment resulting from the Debtor's failure to file a proposal pursuant to section 50.4(8) of the BIA; and
- (c) Any assignment in bankruptcy made in respect of the Debtor;

the transaction as contemplated by the ASA and the vesting of the Assets in the Purchasers pursuant to this Order shall be binding on any trustee in bankruptcy that may be appointed in respect of the Debtor and shall not be void or voidable by creditors of the Debtor, nor shall it constitute or be deemed to be a fraudulent preference, assignment, fraudulent conveyance, transfer at undervalue, or other reviewable transaction under the BIA or any other applicable federal or provincial legislation, nor shall it constitute oppressive or unfairly prejudicial conduct pursuant to any applicable federal or provincial legislation.

8. **THIS COURT DIRECTS** the Receiver to segregate the proceeds of sale of the LMS Units (as defined in the First Report) received by the Receiver from the Auctioneer (the "LMS Proceeds"), which LMS Proceeds shall not be distributed by the Receiver except by further order of this Court.

VIN REGISTERED SETAY UNITS

9. **THIS COURT AUTHORIZES** the Receiver to (a) return the VIN Registered Setay Units, as defined in the First Report and as itemized in Schedule "B" hereto (the "VIN Registered Setay Units") to Setay Motors Inc. ("Setay"), and (b) to pay all rent owing to Setay in respect of the VIN Registered Setay Units for the period beginning on August 25, 2022 and ending on the date that the VIN Registered Setay Units are returned to Setay, in the amounts required by the applicable Setay Lease (as defined in the First Report).

SHORT TERM LMS UNITS

10. THIS COURT AUTHORIZES the Receiver to return the Short Term LMS Units, as defined in the Supplement and as itemized in Schedule "B" hereto (the "Short Term LMS Units") to LMS Rail Services Limited.

SEALING

11. 10. THIS COURT ORDERS AND DECLARES that the Confidential Appendices to the First Report be and are hereby sealed and shall be treated as confidential until (a) the later of (i) the end of the Auction Period (as defined in the ASA), or (ii) all Assets are sold to Purchasers, or (b) further order of this Court.

APPROVAL OF ACTIVITIES

12. 11. THIS COURT ORDERS that the activities of the Receiver described in the First Report, occurring between September 23, 2022 and October 19, 2022, in relation to the Debtor

and these proceedings, are hereby ratified and approved, provided, however, that only the Receiver, in its personal capacity and only with respect to its own personal liability, shall be entitled to rely upon or utilize in any way such approval.

GENERAL

- 13. 12. THIS COURT HEREBY REQUESTS the aid and recognition of any court, tribunal, regulatory or administrative body having jurisdiction in Canada, the United States or any other jurisdiction to give effect to this Order and assist the Purchasers, the Receiver and their respective agents in carrying out the terms of this Order. All courts, tribunals, regulatory and administrative bodies are hereby respectfully requested to make such orders and to provide such assistance to the Purchasers and the to the Receiver, as an officer of this Court, as may be necessary or desirable to give effect to this Order or to assist the Purchasers, the Receiver and their respective agents in carrying out the terms of this Order.
- 14. 13. THIS COURT ORDERS that this order is effective from today's date and is made and enforceable without any need for entry or filing.

Re: Allied Track Services - Unauthorized Repossession of GMC Sierra Denali

As you are aware, we are counsel to KSV Restructuring Inc. ("KSV"), in its capacity as receiver and manager (in such capacity, the "Receiver") of 2806401 Ontario Inc. o/a Allied Track Services ("Allied"). A copy of the order of Mr. Justice Osborne dated September 23, 2022, appointing the Receiver, which was provided to you by email on Friday, October 21, 2022, is enclosed herewith (the "Appointment Order").

This letter follows our discussion on Friday, October 21, 2022 and my two emails to you on the same date, copies of which are enclosed.

On our Friday call, we discussed that the Receiver has undertaken a review of the lease agreement dated June 10, 2021 between Allied and Wheaton Chevrolet Buick Cadillac GMC Inc. ("Wheaton") and the associated registrations made by Wheaton against Allied under the British Columbia *Personal Property Security Act*, and that on the basis of such review the Receiver has concluded that Wheaton's deemed security interest in the 2021 GMC Sierra Denali (the "Leased Truck") has priority to Allied's other secured creditors. We also discussed that the Receiver was not in a position to return the Leased Truck to Wheaton until the Receiver's motion had been heard by the Ontario Court on Friday, October 28, 2022, including because the Receiver had not yet determined whether Allied's creditors would object to the Receiver returning the Leased Truck to Wheaton. At your request, I confirmed this discussion in the enclosed email sent at 5:41 (Toronto Time) on Friday, October 21, 2022.

Following our discussion, the Receiver was informed that representatives of Wheaton had contacted representatives of Allied to advise that Wheaton had instructed agents to take possession of the Leased Truck. In response to this, I sent you the enclosed email at 6:14 (Toronto Time), advising that the Receiver objected to Wheaton taking possession of the Leased Truck, and referring you to Paragraphs 9 and 10 of the Appointment Order. This email specifically advised that:

if Wheaton attempts to seize or repossess the Denali, it will be in breach of the attached order and in contempt of Court. If what we have heard is correct, and representatives of Wheaton are on their way to seize the vehicle, I would encourage you to contact them and tell them to stop, immediately. Should you choose to take action in breach of the attached Court order, the Receiver reserves all of its rights against Wheaton.

My email further advised that:

The attached appointment order was made under the authority of the *Bankruptcy and Insolvency Act*, and therefore has Federal application. In other words, it is effective in British Columbia.

We have been advised today by Allied representatives that agents of Wheaton did, in fact, attend at Allied's yard and seize the Leased Truck on Friday, October 21. We understand that an Allied representative spoke to Dave Wheaton on Friday, and was told that if he did not turn the Leased Truck over to Wheaton's agents, Wheaton would have it towed.

Wheaton, the corporation, and Dave Wheaton, personally, have acted in breach of an order of the Ontario Superior Court, and are in contempt of Court. You were specifically advised of the relevant provisions of the Appointment Order, and Wheaton has knowingly and intentionally breached them.

The Receiver will be reporting Wheaton's breach of the Appointment Order to the Court in a forthcoming report to Court, and attaching this letter. The Receiver furthermore reserves all of its rights against Wheaton, including its right to seek damages and costs against Wheaton for its breach, which costs shall include the professional fees incurred by the Receiver and Blakes as a result of Wheaton's disregard for the Appointment Order.

The Receiver considers Wheaton's conduct to be particularly egregious in light of the fact that you were specifically informed that the Leased Truck would be returned to Wheaton following the October 28 hearing if no objections from creditors were raised. Should any such objections be raised, the Receiver will take all steps within its power to recover the Leased Truck, including without limitation seeking an order declaring Wheaton in contempt and directing that the Leased Truck be returned. All of the Receiver's costs associated with such steps shall be the liability of Wheaton.

If Wheaton has not retained counsel on this matter, it should do so.

Further to the below, I have just spoken with the Receiver, who understands from Tom at Allied that Wheaton may have instructed agents to pick up the Denali today. As I indicated below, the vehicle is currently in the possession of the Receiver, an officer of the Court, and it is subject to a motion returnable on October 28. Moreover, pursuant to Paragraphs 9 and 10 the attached Order of Justice Osborne, all creditors of Allied are stayed from exercising remedies against Allied or "the Property" (as defined in the Order) without the consent of the Receiver. The attached appointment order was made under the authority of the *Bankruptcy and Insolvency Act*, and therefore has Federal application. In other words, it is effective in British Columbia.

Whether or not Wheaton owns the vehicle, by operation of the *Personal Property Security Act*, Allied's creditors have an interest in it. We have reported to the Court that Wheaton's deemed security interest has priority, however that is not a license to exercise self-help remedies and seize the truck.

Accordingly, if Wheaton attempts to seize or repossess the Denali, it will be in breach of the attached order and in contempt of Court. If what we have heard is correct, and representatives of Wheaton are on their way to seize the vehicle, I would encourage you to contact them and tell them to stop, immediately. Should you choose to take action in breach of the attached Court order, the Receiver reserves all of its rights against Wheaton.

I hope that after our conversation this afternoon, what we are hearing about potential repossession is simply a miscommunication, and that Wheaton is not attempting to seize the vehicle. We hope to work together with you until the motion on the 28th of October, as indicated in my emails below. If Wheaton proceeds to repossess the vehicle, the opportunity to work together will be gone.

EQUIPMENT MASTER LEASE AGREEMENT

This equipment lease agreement (the "Lease") made and effective on this 22nd day of March, 2021(the "Effective Date").

Between:

LMS Rail Services Limited Trading as LMS Rail Equipment Services 1304 Front St, P.O. Box 607 Hearst, Ont. P0L 1N0

("Lessor")

And

2806401 Ontario Inc. Allied Track Services Corp. 169A South Service Road Grimsby, Ont. L3M 4H6

("Lessee")

TERMS AND CONDITIONS

1. EQUIPMENT

The Lessee agrees to lease from the Lessor the equipment listed on the "Equipment Lease Agreement" set forth in Schedule "A" (herein after referred to as "the Agreement") together with any accessories incorporated therein and/or affixed thereto, hereinafter collectivity called the Equipment.

2. TERM

This Lease shall be effective for a period of <u>60 months</u> from the Effective Date (the "Term"). It is understood and agreed by the parties hereto that the lease period of each piece of equipment, if any, is set forth on the agreement.

3. TERMINATION

Should either party breach any of its obligations under this Lease, the other party may terminate the Lease (including any Agreement) effective fifteen (15) business days following notice from the non-defaulting party if the non-performance has not been cured within such period and without prejudice to damages that could be claimed by the non-defaulting party. Either party may terminate the Lease if the other party becomes unable to pay its debts in the ordinary course of business; goes into liquidation (other than for the purpose of a genuine amalgamation or restructuring); has a receiver appointed over all or part of its assets; enters into a composition or voluntary arrangement with its creditors; or any similar event occurs in any jurisdiction, all to the extent permitted by law. Lessee may also terminate the Lease for convenience within thirty (30) business days subject to its obligation to make payment for the rental up to the date of termination.

RENTAL

The Lessee agrees to pay the rent for the term of the Agreement in consecutive payments in the amounts shown on page one of Schedule "A" — Equipment Lease Agreement. Rental shall be payable to the Lessor commencing on the date of delivery unless agreed to otherwise in writing. Notwithstanding the expiration of the Term, the Lessee will continue to be responsible for the rental for the rental payments until the Equipment is returned to the Lessor. Rental payments under the terms and conditions of this Lease are due on the first day of each month. If payment is not received at the Lessor's office within fourteen (14) days of being due, it shall constitute an event or default, and the Lessor may remove the equipment from the Lessee's property.

WARRANTY

The Lessee has selected the Equipment of the type and quantity described on the agreement. The Lessor makes no warranty to the Lessee and expressly disclaims any warranty either express or implied, regarding the Equipment except that the Equipment shall be in good condition and working order at the time of delivery.

LESSEE'S INSPECTION AND ACCEPTANCE

The Lessee shall inspect the Equipment upon its arrival and shall with forty-eight (48) hours thereafter (Saturdays, Sundays and holidays excepted) give the Lessor telephone notice of any Equipment defects. Upon receipt of such notice, the Lessor shall, at its option, either repair or replace any defective Equipment.

7. MAJOR REPAIRS

Lessor shall be responsible to complete and pay for all major repairs resulting from major components failure (such as engine or transmission) ("Major Repairs"), unless such failure is the result of Lessee's neglect or lack of maintenance. In the event that Lessee is obligated to complete any Major Repairs in the case of an emergency, or to ensure continued use of the Equipment, Lessor shall reimburse Lessee for all reasonable and actual costs incurred by Lessee for such repairs.

Prior written consent is required from Lessor before repairs are initiated, such consent not to be unreasonably withhold.

8. TRANSPORTATION

The Lessee shall choose the method of, and pay for, the shipment of the Equipment from the point of origin; however, arrangements for shipment shall be provided by the Lessor. The Lessee shall arrange for and pay the cost of unloading the Equipment upon arrival. The Lessee shall arrange and pay the cost of loading, securing and shipping the Equipment to the point of return.

9. INSTALLATION, USE, MAINTENANCE AND REPAIR

The Lessor shall not have any obligation to install, erect, test, adjust, or service the Equipment throughout the Term of this lease.

The Lessee, at its own cost and expense, shall:

- a) Pay all charges in connection with the unloading and loading, installation, operation and storage of the Equipment.
- b) Make regular preventative maintenance inspection of the Equipment and shall service, repair and maintain (subject to Section 7 hereof) the Equipment in good operating condition and in compliance with the laws of the province or provinces in which the Equipment is located, and with any applicable provincial or federal regulations.
- c) furnish the tires, tracks, tubes, motor oils, fuel, lubricants, and other operating parts, all expendable items such as, but not limited to, wipers and bulbs; together with all supplies necessary for the proper and efficient operation of the Equipment.
- d) Use and operate the Equipment only in the normal and ordinary course of the Lessee's business.
- e) Cause the Equipment to be operated only by a safe, carefully selected, properly trained and legally licensed operator, who shall be an employee or agent of the Lessee and subject to the Lessee's exclusive direction and control. No persons other than the Lessee's agents or employees engaged in their regular duties shall be carried in or on the Equipment and at no time will any person be carried in or on the Equipment while the Equipment is being pulled by any other vehicle.
- f) Comply with all applicable laws, ordinances, regulations, requirements, and rules with respect to the use, maintenance, and operation of the Equipment.
- g) Take good and proper care of the Equipment and make all repairs and replacements (subject to Section 7 hereof) necessary to maintain, preserve, and keep the Equipment in good condition and working order. (The Lessee shall not, however, make any alterations, additions or improvements to the Equipment without the prior written consent of the Lessor.) All repairs, replacements, parts, devices, accessories, and improvements of whatsoever kind of nature furnished or affixed to the Equipment shall belong to and become part of the property of the Lessor.

10. INSURANCE AND INDEMNITY

The Lessee assumes the entire risk of loss, theft, or damage to the Equipment, and no such loss, theft, or damage shall relieve the Lessee of its obligations under this Lease Agreement. The Lessee agrees to and does hereby indemnify from, and against all claims, costs, expenses, damages, and liabilities, including reasonable attorney's fees, resulting from or incidental to the use, operation, or storage of the Equipment during the Term from third parties claims. The Lessee agrees to carry public liability and property damage insurance for Equipment listed in attached "Schedule A – Equipment Lease Agreement" in such amounts as set forth in Section 25 below.

Neither party will be liable to the other party for consequential, indirect or punitive damages for any cause of action, whether in contract, tort or otherwise. Consequential damages include, but are not limited to, lost profits, lost revenues and lost business opportunities, whether the other party was or should have been aware of the possibility of these damages, including any damages arising from loss of use or delay or disruption services.

11. LOSS, THEFT, OR DAMAGE

In the event of loss, theft, or damage to the Equipment in whole or in part, the Lessee shall promptly so notify the Lessor and the Lessee, at the Lessee's option shall:

- a) place the Equipment in good condition and working order, or
- b) if the Lessee determines that any Equipment is beyond repair, pay to the Lessor, within ten (10) days such notification, the loss value thereof which shall be an amount equal to the sum of:
- i) All rents and other amount due and owing under the Lease and Agreement at the time of such loss, theft, or damage, plus;
 - ii) The fair market value of the Equipment as shown on page one of Schedule "A" – Equipment Lease Agreement can be revised at the time of total loss to an amount agreed to by both parties. A third party chosen by both Lessor and Lessee can establish a binding fair market value. Upon such payment, the Lease shall terminate with respect to the item of Equipment so paid for and the Lessee shall thereupon become the owner thereof.

12. OWNERSHIP AND CONTROL

The Equipment shall all times remain the property of the Lessor and the Lessee shall have no right or property interest therein, but only the right to use same under the lease. The Lessor shall have the right to display notice of its ownership by affixing to the Equipment an identifying plate, stencil, or other indicia of ownership. The Lessee shall not part with possession of control of the Equipment without the prior written consent of the Lessor. The Lessor shall have the right to inspect the Equipment during the Lessee's normal business hours.

13. ADDITIONAL RENT

When Lessor is obligated to pay fines, tickets or levies resulting from use of the Equipment by Lessee, the Lessor will add these charges to the following month's rental charges.

14. LATE CHARGES

If the Lessee fails to pay the rental or any other charges within forty (40) days from the invoice date, then the Lessor may impose a late charge on the unpaid balance at the rate of one and one half percent (1½%) per month or the maximum rate provided by law, whichever is less.

15. ENCUMBRANCES

The Lessee shall keep the Equipment free and clear of all levies, liens, claims, and encumbrances.

16. RETURN OF EQUIPMENT

Upon the termination of this Lease, whether by expiration of the Term or otherwise, the Lessee, at its own expense, will return the Equipment to the Lessor at the Point of Return or to other such party of place as the Lessor may designate in writing; provided however, that the shipping costs to the Lessee shall not exceed the cost to the Point of Return. If the Lessee fails or refuses to so return and deliver the Equipment, the Lessor shall have the right, without notice of demand, to enter the premises where the Equipment may be found, forcibly if necessary and take possession of and remove the Equipment without legal process. Upon return, as aforesaid, the Equipment will be in the same condition as when delivered to the Lessee, normal wear and tear excepted, and in good condition and working order.

17. ASSIGNMENT

The Lessee shall not assign, transfer, pledge, hypothecate, or otherwise dispose of this lease or any interest herein or subject or lend the Equipment or permit it to be used by anyone other than the Lessee and Lessee's employees, without prior written consent.

18. DEFAULT

Any of the following events or conditions shall constitute a default of a party under this Lease:

- a) default in the payment of rent or any other sums due hereunder for a period of fourteen (14) days after the same become due;
- b) any other breach of terms and conditions of this Lease;
- if any writ or order of attachment, execution, or other legal process against a party is levied on any or all Equipment and is not released or satisfied with ten (10) days;
- d) the institution of a proceeding in bankruptcy, receivership, or insolvency against or by a party or if a party shall enter into an arrangement with its creditors;

19. REMEDIES

The non-defaulting party may terminate the Lease effective ten (10) business days following notice from the non-defaulting party if the non-performance has not been cured within such period and without prejudice to damages that could be claimed by the non-defaulting party. Either Party may terminate the Lease immediately if the other party becomes unable to pay its debts in the ordinary course of business; goes into liquidation (other than for the purpose of a genuine amalgamation or restructuring); has a receiver appointed over all or part of its assets; enters into a composition or voluntary arrangement with its creditors; or any similar event occurs in any jurisdiction, all to the extent permitted by law.

20. NOTICE AND WAIVERS

All notices relating hereto shall be delivered in person to an officer of the Lessor or Lessee or shall be mailed certified or registered to the Lessor or the Lessee at their respective addresses shown or at any other address hereinafter furnished by the notice given in like manner. A waiver of a specific default shall not be a waiver of any other subsequent default. No waiver by the Lessor of any provisions hereof shall constitute a waiver of any other matter and all waivers shall be in writing and executed by an office of the Lessor. No failure on the part of the Lessor to exercise, and no delay in exercising, any right or remedy hereunder shall operate as a waiver thereof.

21. ENTIRE AGREEMENT

This instrument constitutes the entire Agreement between the parties and may not be modified except by a written instrument signed by the Lessor and the Lessee. The lease shall not constitute a contract until accepted in writing by an authorized representative of the Lessor.

22. ADDITIONAL DOCUMENTS

At the request of a party, the other party shall execute and deliver to such party any documents as such party shall deem necessary or desirable for the purpose of recording or filing.

23. MISCELLANEOUS

Any provision of this instrument prohibited by the law in any province shall, as to such province, be ineffective to the extent to such prohibition without invalidating the remaining provisions of this instrument. 24. LAWS OF ONTARIO CONTROL THIS LEASE AGREEMENT

The Lessor and Lessee both stipulate and agree that in the event of any dispute involving this Lease Agreement, the Lessor and the Lessee may file suit in the courts, whether federal or provincial, located in the Province of Ontario.
