SECOND SUPPLEMENT TO THE FIRST REPORT OF KSV RESTRUCTURING INC. AS RECEIVER AND MANAGER

NOVEMBER 16, 2022

1.0 Introduction

1. This report (the "Second Supplement") supplements the Receiver's First Report to Court dated October 20, 2022 (the "First Report") and the Supplement to the First Report dated October 26, 2022 (the "Supplement").

1.1 Restrictions

1. This Second Supplement is subject to the restrictions in the First Report.

2.0 Conveyance of Leased Equipment

- 1. On October 28, 2022, the Court issued an approval and vesting order (the "AVO") that, among other things:
 - a) approved the Auction Services Agreement dated October 18, 2022 (the "ASA"),
 - b) appointed Corporate Assets Inc. (the "Auctioneer") as agent of Allied to sell the Assets (as defined in the AVO);
 - c) authorized the Receiver to sell certain vehicles leased to Allied by Danella Rental Systems Ltd. ("Danella"), LMS Rail Services Limited ("LMS") and Setay Motors Inc. ("Setay", together with Danella and LMS, the "Lessors"); and
 - d) provided for the vesting of all of Allied's right, title and interest in and to the Assets (as defined in the AVO) to purchasers, free and clear of all encumbrances.
- 2. Since the granting of the AVO, the Receiver and the Auctioneer have been working diligently to market the assets scheduled in the AVO. Pursuant to the terms of the ASA, the Auctioneer has negotiated "pre-auction" sales for certain vehicles and equipment, which in the opinion of the Auctioneer are on sufficiently favourable economic terms that the Auctioneer recommended proceeding with the sales prior to the auction.
- 3. In the context of negotiating and attempting to close the pre-auction sales, it has become apparent to the Receiver that the terms of the AVO may not be sufficient to facilitate the transfer of registered title in certain assets that the Receiver and the Auctioneer have been authorized by the AVO to sell.
- 4. The Receiver is accordingly seeking amendments to the AVO which, in the Receiver's view, are technical in nature and intended to facilitate the orders set out in the AVO, as issued.
- 5. This Second Supplement summarizes the amendments being sought, and provides a short update on certain other leased vehicles.

2.1 Amendments to the AVO

- 1. A blackline of the AVO, as issued, marked against the amended and restated AVO sought by the Receiver, is attached as Appendix "A".
- 2. Paragraph 4 of the AVO, as issued, authorizes the Receiver and the Auctioneer to sell certain vehicles leased to Allied by the Lessors, on the following terms:
 - 4. THIS COURT ORDERS that, without limiting the generality of Paragraph 2, the Receiver and the Auctioneer are hereby authorized to sell, pursuant to the terms of the ASA, the Assets defined in the First Report as the LMS Units (other than the Short Term LMS Units, as defined in the Supplement), the Danella Units and the Unregistered Setay Units, which for greater certainty are scheduled as Assets to this Order.

- 3. Paragraph 5 of the AVO includes standard vesting language, vesting in the purchaser of the Assets (which includes the vehicles leased by the Lessors to Allied that are authorized to be sold in Paragraph 4 of the AVO), all of Allied's right title and interest in such Assets, free and clear of Claims and Encumbrances (as defined in the AVO):
 - THIS COURT ORDERS AND DECLARES that effective upon the delivery of a bill of sale by the Auctioneer to a purchaser (each, a "Purchaser"), any sale of the Assets set out in such bill of sale by the Auctioneer on behalf of the Debtor to a Purchaser shall be free and clear of and from any and all security interests (whether contractual, statutory or otherwise), hypothecs, mortgages, trusts or deemed trusts (whether contractual, statutory or otherwise), liens, executions, levies, charges or other financial or monetary claims, whether or not they have attached or been perfected, registered or filed and whether secured, unsecured or otherwise (collectively, the "Claims") including, without limiting the generality of the foregoing: (i) charges created by the order of Mr. Justice Osborne issued on September 23, 2022, and (ii) all charges, security interests or claims evidenced by registrations pursuant to the Personal Property Security Act (Ontario) or any other personal property registry system (all of the foregoing, collectively, "Encumbrances"), and for greater certainty, this Court orders that all of the Claims and Encumbrances affecting or relating to the Assets set out in such bill of sale shall be deemed expunged and discharged as against the Assets and that all of the Debtor's right, title and interest in and to the Assets shall vest absolutely in the applicable Purchaser.
- 4. While the AVO, as issued, explicitly authorizes the Receiver to sell the vehicles leased by the Lessors to Allied, vests out encumbrances, and transfers all of <u>Allied's</u> right, title and interest in the Assets to the purchaser, the AVO does not explicitly transfer all of the <u>Lessors'</u> right, title and interest in the Assets to a purchaser.
- 5. Due to the number of units leased by the Lessors to Allied that are subject to paragraph 4 of the AVO (50 in total: 3 by Danella, 44 by LMS and 3 by Setay), the Receiver has been unable to obtain a report from the applicable motor vehicles registries regarding which entity is registered as owner, but the Receiver understands that many, if not all, of the vehicles authorized to be sold by Paragraph 4 of the AVO are registered in the name of the Lessors, not Allied.
- 6. Based on the Auctioneer's experience working to close pre-auction sales, some of which include vehicles leased to Allied by the Lessors, it is apparent to the Receiver that the AVO, as issued, may not be sufficient for registrars at applicable vehicle registry offices to facilitate the transfer of title to those Assets.
- 7. Accordingly, in order to give full effect to the AVO as intended, the Receiver is seeking the Court's indulgence to amend the AVO, to include the following provisions:
 - a) Vesting in the purchaser the right, title and interest of Danella, LMS or Setay, as applicable, in and to the Assets authorized to be sold by the Receiver, in the same way that the AVO vests the right, title and interest of Allied in and to all of the Assets:
 - Deeming Danella, LMS and Setay to consent to the transfer of title for the purposes of recording the change of registered ownership in any applicable registry;

- c) Authorizing provincial motor vehicle registrars to rely on the foregoing deeming provision; and
- d) Requesting regulatory authorities to enter the purchaser of such Assets as registered owner.
- 8. None of the requested amendments to the AVO change the scope or effect of the AVO, as issued. No new assets are being included. The Receiver is seeking only to give effect to the authorization it was granted by Paragraph 4 of the AVO to sell the vehicles leased to Allied by the Lessors.
- 9. The Receiver is also seeking an amendment to the AVO to include an express authorization for the Receiver, or its counsel, to file discharges in applicable personal property security registries in order to give effect to the vesting provisions of the AVO, as issued. While the Receiver does not require specific authorization to do this from a regulatory perspective, and could register discharges without this amendment, the Receiver believes that it is prudent to obtain such authority given that it anticipates having to file such discharges if certain secured creditors are not cooperative, or are not promptly responsive.
- 10. The Receiver notified the Lessors of the amendments it is seeking on November 15, 2022, provided a blackline of the AVO to identify the changes, and requested their consent to the amendments. As of the date of this Second Supplement, Setay has advised the Receiver that it consents to the amendments, and Danella and LMS have responded through counsel but have not formally consented to or opposed the amendments.
- 11. A clean copy of the order sought by the Receiver, which authorizes the amendments to the AVO and attaches an amended and restated AVO as a schedule, is attached as Appendix "B".

2.2 Update on Buyouts

- The Supplement advised that the Receiver would be seeking to negotiate buyouts of equipment leased to Allied by Calmont Leasing Ltd. ("Calmont"), Caterpillar Financial Services Limited ("Caterpillar"), Meridian OneCap Credit Corp. ("Meridian") Valiant Financial Services Inc. ("Valiant") and Vault Credit Corporation ("Vault").
- 2. The Receiver was able to agree to terms with Caterpillar, Meridian and Vault for the buyout of equipment leased to Allied by those lessors. The buyouts have been completed, and the Auctioneer will be selling the respective assets. Anticipating that a buyout would be achievable, the Receiver included the Caterpillar, Meridian and Vault vehicles in the AVO. Accordingly, no amendment to the AVO is necessary to reflect the buyouts.
- 3. The Receiver was not able to agree to terms with Calmont or Valiant. The Calmont and Valiant equipment has either been returned, or is in the process of being returned. The Calmont equipment was not included in Schedule "A" to the AVO, and so no amendment to the AVO is necessary. The Valiant units were included in Schedule "A" to the AVO (anticipating that a buyout would be achievable), and accordingly the amendments sought to the AVO include the deletion from Schedule "A" of the three trucks leased to Allied by Valiant.

3.0 Recommendations

1. Based on the foregoing, the Receiver respectfully recommends that this Honourable Court make an order amending the AVO in the manner set out in Appendix "A" hereto.

AMENDED AND RESTATED ORDER

(Approving Auction Services Agreement, and Ancillary Matters)

THIS MOTION made by KSV Restructuring Inc., ("KSV") in its capacity as receiver and manager (in such capacity, the "Receiver"), without security, of all of the assets, undertakings and properties of 2806401 Ontario Inc. o/a Allied Track Services (the "Debtor") for an order, among other things, approving the auction services agreement dated October 19, 2022 (the "ASA") between the Receiver and Corporate Assets Inc. (the "Auctioneer") to (i)

permit the Auctioneer to conduct a sale of the assets set out in the ASA, and (ii) vesting all right, title and interest of the Debtor in and to the assets described in Schedule "A" to this Order, and any assets of the Debtor that may be added to Schedule A of the ASA by the Receiver and the Auctioneer (, and all right, title and interest of any registered owner of any Leased Units (defined below) described in Schedule "A" (all such assets listed in Schedule "A", including the Leased Units, the "Assets"), to the purchasers as identified by the Auctioneer pursuant to the ASA, was heard this day by judicial videoconference via Zoom in Toronto, Ontario.

ON READING the First Report of KSV as Receiver dated October 19, 2022 (the "First Report"), the Supplement to the First Report of KSV as Receiver dated October 26, 2022 (the "Supplement") and on hearing the submissions of counsel for the Receiver, and those other counsel and parties listed on the Participant Information Form, no one else appearing although duly served as appears from the affidavit of service of Nancy Thompson sworn October 21, 2022.

SERVICE

1. **THIS COURT ORDERS** that the time for service of the Notice of Motion and the Motion is hereby abridged and validated so that this motion is properly returnable today and hereby dispenses with further service thereof.

APPROVAL AND VESTING

2. THIS COURT ORDERS AND DECLARES that the ASA and the transactions contemplated thereby are hereby approved, with such minor amendments as the Receiver and the Auctioneer may deem necessary and agree to in writing. Subject to the provisions of this Order, the Receiver is authorized and directed to take such additional steps and execute such additional

documents as may be necessary or desirable to implement the ASA and the transactions contemplated therein.

- 3. **THIS COURT ORDERS** that subject to the terms of the ASA, the Auctioneer be and hereby is appointed as agent of the Debtor to sell the Assets.
- 4. THIS COURT ORDERS that, without limiting the generality of Paragraph 2, the Receiver and the Auctioneer are hereby authorized to sell, pursuant to the terms of the ASA, the Assets defined in the First ReportSchedule "A" hereto as the LMS Units (other than the Short Term LMS Units, as defined in the Supplement), the Danella Units and the Unregistered Setay Units, which for greater certainty are scheduled as Assets to this Order. (collectively, the "Lessor Units"), and that effective upon the delivery of a bill of sale by the Auctioneer to a purchaser (each, a "Purchaser") in respect of any Lessor Unit:
 - <u>all of the right, title and interest of LMS Rail Services Limited ("LMS"), in and to</u>

 <u>the applicable LMS Unit listed in the bill of sale shall vest absolutely in the applicable Purchaser;</u>
 - (b) all of the right, title and interest of Danella Rental Systems, Inc. ("Danella") in and to the applicable Danella Unit listed in the bill of sale shall vest absolutely in the applicable Purchaser, and
 - all of the right, title and interest of Setay Motors Inc. ("Setay") in and to the applicable Unregistered Setay Unit shall vest absolutely in the applicable Purchaser;

in each case, free and clear of all Claims and Encumbrances (as defined below), subject to Paragraph 6 hereof.

- 4.A THIS COURT ORDERS that LMS, Danella and Setay, as applicable, are hereby deemed to have consented to the transfer of title from them to the applicable Purchaser for the purposes of recording the change of registered ownership of any LMS Unit, Danella Unit or Unregistered Setay Unit, and any provincial motor vehicles registrar shall be entitled to rely on this deeming provision, without liability to LMS, Danella or Setay, in connection with transferring registered title in any Leased Unit to a Purchaser.
- 5. THIS COURT ORDERS AND DECLARES that effective upon the delivery of a bill of sale by the Auctioneer to a purchaser (each, a "Purchaser"), any sale of the Assets set out in such bill of sale by the Auctioneer on behalf of the Debtor to a Purchaser shall be free and clear of and from any and all security interests (whether contractual, statutory or otherwise), hypothecs, mortgages, trusts or deemed trusts (whether contractual, statutory or otherwise), liens, executions, levies, charges or other financial or monetary claims, whether or not they have attached or been perfected, registered or filed and whether secured, unsecured or otherwise (collectively, the "Claims") including, without limiting the generality of the foregoing: (i) charges created by the order of Mr. Justice Osborne issued on September 23, 2022, and (ii) all charges, security interests or claims evidenced by registrations pursuant to the *Personal Property* Security Act (Ontario) or any other personal property registry system (all of the foregoing, collectively, "Encumbrances"), and for greater certainty, this Court orders that all of the Claims and Encumbrances affecting or relating to the Assets set out in such bill of sale shall be deemed expunged and discharged as against the Assets and that all of the Debtor's right, title and interest in and to the Assets shall vest absolutely in the applicable Purchaser.

- <u>THIS COURT ORDERS</u> that the Receiver, or its counsel, is hereby authorized to register a discharge statement in the applicable personal property security registry, discharging any registered Encumbrance that is vested out of any Asset pursuant to Paragraph 5 hereof.
- 6. THIS COURT ORDERS that for the purposes of determining the nature and priority of Claims, the net proceeds payable to the Receiver from the sale of the Assets (the "Net Proceeds") shall stand in the place and stead of the Assets, and that from and after the delivery of the bill of sale delivered by the Auctioneer to the Purchaser, all Claims and Encumbrances shall attach to the Net Proceeds from the sale of the Assets with the same priority as they had with respect to the Assets immediately prior to the sale as if the Assets had not been sold and remained in the possession or control of the person having that possession or control immediately prior to the sale.

7. **THIS COURT ORDERS** that, notwithstanding:

- (a) The pendency of these proceedings;
- (b) Any applications for a bankruptcy order now or hereafter issued pursuant to the *Bankruptcy and Insolvency Act* (Canada) (the "**BIA**") in respect of the Debtor, any bankruptcy order issued pursuant to any such application, or any deemed assignment resulting from the Debtor's failure to file a proposal pursuant to section 50.4(8) of the BIA; and
- (c) Any assignment in bankruptcy made in respect of the Debtor; the transaction as contemplated by the ASA and the vesting of the Assets in the Purchasers pursuant to this Order shall be binding on any trustee in bankruptcy that may be appointed in respect of the Debtor and shall not be void or voidable by creditors of the Debtor, nor shall it constitute or be deemed to be a fraudulent preference, assignment, fraudulent conveyance,

transfer at undervalue, or other reviewable transaction under the BIA or any other applicable federal or provincial legislation, nor shall it constitute oppressive or unfairly prejudicial conduct pursuant to any applicable federal or provincial legislation.

- 8. THIS COURT DIRECTS the Receiver to segregate the net proceeds of sale of the LMS Units (as defined in the First ReportSchedule "A" hereto) received by the Receiver from the Auctioneer (the "LMS Proceeds"), which LMS Proceeds shall not be distributed by the Receiver except by further order of this Court, sought on notice to LMS.
- 9. **THIS COURT DIRECTS** the Receiver to segregate the net proceeds of sale of the Danella Units (as defined in the First ReportSchedule "A" hereto) received by the Receiver from the Auctioneer (the "Danella Proceeds"), which Danella Proceeds shall not be distributed by the Receiver except by further order of this Court, sought on notice to Danella.

VIN REGISTERED SETAY UNITS

10. **THIS COURT AUTHORIZES** the Receiver to (a) return the VIN Registered Setay Units, as defined in the First Report and as itemized in Schedule "B" hereto (the "VIN Registered Setay Units") to Setay Motors Inc. ("Setay"), and (b) to pay all rent owing to Setay in respect of the VIN Registered Setay Units for the period beginning on August 25, 2022 and ending on the date that the VIN Registered Setay Units are returned to Setay, in the amounts required by the applicable Setay Lease (as defined in the First Report).

SHORT TERM LMS UNITS

11. **THIS COURT AUTHORIZES** the Receiver to return the Short Term LMS Units, as defined in the Supplement and as itemized in Schedule "B" hereto (the "Short Term LMS Units") to LMS Rail Services Limited.

SEALING

12. **THIS COURT ORDERS AND DECLARES** that the Confidential Appendices to the First Report be and are hereby sealed and shall be treated as confidential until (a) the later of (i) the end of the Auction Period (as defined in the ASA), or (ii) all Assets are sold to Purchasers, or (b) further order of this Court.

APPROVAL OF ACTIVITIES

13. **THIS COURT ORDERS** that the activities of the Receiver described in the First Report, occurring between September 23, 2022 and October 19, 2022, in relation to the Debtor and these proceedings, are hereby ratified and approved, provided, however, that only the Receiver, in its personal capacity and only with respect to its own personal liability, shall be entitled to rely upon or utilize in any way such approval.

GENERAL

- 14. THIS COURT HEREBY REQUESTS the aid and recognition of any court, tribunal, regulatory or administrative body having jurisdiction in Canada, the United States or any other jurisdiction to give effect to this Order and assist the Purchasers, the Receiver and their respective agents in carrying out the terms of this Order. All courts, tribunals, regulatory and administrative bodies are hereby respectfully requested to make such orders and to provide such assistance to the Purchasers and the to the Receiver, as an officer of this Court, as may be necessary or desirable to give effect to this Order or to assist the Purchasers, the Receiver and their respective agents in carrying out the terms of this Order.
- 15. THIS COURT HEREBY REQUESTS, without limiting the generality of Paragraph 14, that upon being presented with a bill of sale for any Asset (including without limitation any Lessor Unit) and a copy of this Order, any court, tribunal, regulatory or administrative body having jurisdiction in Canada, the United States or any other jurisdiction (including without

limitation the Ontario Ministry of Transportation, ServiceOntario, the British Columbia Ministry
of Transportation and Infrastructure, the Insurance Corporation of British Columbia, and the
Alberta Registrar of Motor Vehicles) to enter the applicable Purchaser as the registered owner of
the Asset.

16. 15. THIS COURT ORDERS that this order is effective from today's date and is made and enforceable without any need for entry or filing.

(the "Auctioneer") to

(i) permit the Auctioneer to conduct a sale of the assets set out in the ASA, and (ii) vesting all right, title and interest of the Debtor in and to the assets described in Schedule "A" to this Order, any assets of the Debtor that may be added to Schedule A of the ASA by the Receiver and the Auctioneer, and all right, title and interest of any registered owner of any Leased Units (defined below) described in Schedule "A" (all such assets listed in Schedule "A", including the Leased Units, the "Assets"), to the purchasers as identified by the Auctioneer pursuant to the ASA, was heard this day by judicial videoconference via Zoom in Toronto, Ontario.

ON READING the First Report of KSV as Receiver dated October 19, 2022 (the "First Report"), the Supplement to the First Report of KSV as Receiver dated October 26, 2022 (the "Supplement") and on hearing the submissions of counsel for the Receiver, and those other counsel and parties listed on the Participant Information Form, no one else appearing although duly served as appears from the affidavit of service of Nancy Thompson sworn October 21, 2022.

SERVICE

1. **THIS COURT ORDERS** that the time for service of the Notice of Motion and the Motion is hereby abridged and validated so that this motion is properly returnable today and hereby dispenses with further service thereof.

APPROVAL AND VESTING

2. **THIS COURT ORDERS AND DECLARES** that the ASA and the transactions contemplated thereby are hereby approved, with such minor amendments as the Receiver and the Auctioneer may deem necessary and agree to in writing. Subject to the provisions of this Order, the Receiver is authorized and directed to take such additional steps and execute such additional

documents as may be necessary or desirable to implement the ASA and the transactions contemplated therein.

- 3. **THIS COURT ORDERS** that subject to the terms of the ASA, the Auctioneer be and hereby is appointed as agent of the Debtor to sell the Assets.
- 4. **THIS COURT ORDERS** that, without limiting the generality of Paragraph 2, the Receiver and the Auctioneer are hereby authorized to sell, pursuant to the terms of the ASA, the Assets defined in Schedule "A" hereto as the LMS Units, the Danella Units and the Unregistered Setay Units (collectively, the "**Lessor Units**"), and that effective upon the delivery of a bill of sale by the Auctioneer to a purchaser (each, a "**Purchaser**") in respect of any Lessor Unit:
 - (a) all of the right, title and interest of LMS Rail Services Limited ("LMS"), in and to the applicable LMS Unit listed in the bill of sale shall vest absolutely in the applicable Purchaser;
