- 2. Leave is hereby granted to any person, entity, or party affected by this Order to apply to this Court for a further Order vacating, substituting, modifying, or varying the terms of this Order, with such application to be brought on notice to High Park Shops Inc., the Monitor and any other affected party.
- 5. Service of this Order by e-mail, facsimile, courier, regular mail or personal delivery shall constitute good and sufficient service of this Order.
- 6. The Monitor is at liberty to apply for advice and direction as may be necessary to give full force and effect to the terms of this Order.
