UPON the Application by the Applicant, Kikino Metis Settlement (“**Kikino**”) for an Order declaring that the stay of proceedings (“**Stay**”) in the *Companies’ Creditors Arrangement Act*, R.S.C., 1985, c. C-36 proceedings (“**CCAA Proceedings**”) of AlphaBow Energy Ltd. (“**AlphaBow**”) is no longer operational in respect of Kikino’s proceedings for unpaid surface lease arrears (“**Lease Arrears**”) by AlphaBow before the Metis Settlement Appeal Tribunal (“**MSAT Proceedings**”); **AND UPON** having read the Affidavit of Ameena Quazi sworn November 3,

2025, and the Affidavit of Service of Ameena Quazi sworn on November 3, 2025; **AND UPON** hearing from counsel for Kikino and all other interested parties present;

IT IS HEREBY ORDERED AND DECLARED THAT:

1. Service of notice of the Application and supporting materials is hereby declared to be good and sufficient, no other person is required to have been served with notice of the Application, and time for service of the Application is abridged to that actually given.
2. The Stay is hereby lifted in respect of Kikino for the purpose of permitting Kikino to advance the MSAT Proceedings.
3. Any debt claim due and owing to the Crown in the Right of Alberta by operation of section 121 of the *Metis Settlements Act*, RSA 2000, c M-14 is hereby deemed to be a subrogation of Kikino's claim for the Lease Arrears within the CCAA Proceedings.
