  - b. **Services** consisting of: (i) project management (strategic management, Fusion configuration, and study configuration); and (ii) clinical sciences (clinical consulting, protocol development medical monitoring, and results analysis) that are offered to clients either virtually or in-person/on-site.

(the "Purchaser"), on July 16, 2025, the Receiver sold substantially all of the Property to the Purchaser (the "Transaction"). The principal purpose of the receivership was to complete the Transaction. The Company's main remaining asset is Scientific Research & Experimental Development ("SRED") tax credits that may result in tax refunds payable to the Company.
- 8. NBC is the Company's main secured lender. It is projected to suffer a material shortfall on its loans to the Company after considering any amounts payable to it from the Transaction and the collection of SRED refunds.
