**To: Creditors of Bad Boy Furniture Warehouse Limited (“Bad Boy”)**

We are writing to advise you that on November 9, 2023, Bad Boy commenced restructuring proceedings by filing a Notice of Intention to Make a Proposal (“NOI”) pursuant to section 50.4 of the *Bankruptcy and Insolvency Act* (“BIA”). A copy of the NOI and a preliminary listing of creditors is attached. KSV Restructuring Inc. has been appointed as the Licensed Insolvency Trustee under the NOI (the “Trustee”).

Although the NOI proceeding is pursuant to the BIA, it is important to note that Bad Boy is not bankrupt. The principal purpose of the NOI proceeding is to allow for a stay of proceedings to allow Bad Boy to consider various restructuring options.

At present, creditors are not required to file a proof of claim. The Trustee will provide you with further information and a proof of claim form at a later date.

During the restructuring proceedings:

- pursuant to Section 65.1(1) of the BIA, no person may terminate or amend any agreement with Bad Boy, or claim an accelerated payment, or a forfeiture of the term, under any agreement with Bad Boy, by reason only that Bad Boy is insolvent or by reason of the filing of the NOI;
- pursuant to an order of the Ontario Superior Court of Justice (Commercial List) (the “Court”) granted on November 10, 2023 (the “Stay Order”), no person may terminate, interfere with or cease to perform any contract or agreement with Bay Boy except with leave of the Court. A copy of the Stay Order can be found on the Trustee’s website at: <https://www.ksvadvisory.com/experience/case/bad-boy>;
- no creditor has any remedy against Bad Boy or its property or shall commence or continue any action, execution, or other proceedings against Bad Boy, pursuant to Section 69.1(1) of the BIA;
- pursuant to the Stay Order, Bad Boy’s suppliers and service providers are required to continue to provide goods and services to it, provided that no creditor is required to extend credit to Bad Boy; and
- to the extent applicable, suppliers should discuss directly with their usual Bad Boy representative the terms of payment for goods and/or services that they provide to Bad Boy.


