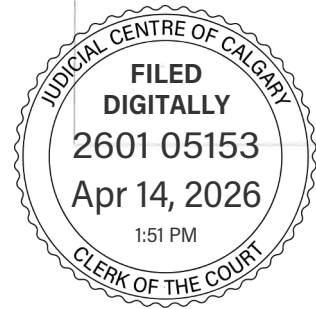

2. Macquarie shall be entitled to deduct its reasonable solicitor and client legal fees incurred in connection with this Order or in connection with the receipt and payment of any amounts under the DPA from the amounts to be remitted to KSV pursuant to paragraph 1 hereof;
