1. On September 24, 2025, Blue Sky Resources Ltd. (the “Debtor”) filed a Notice of Intention to Make a Proposal pursuant to the *Bankruptcy and Insolvency Act*, R.S.C. 1985, c. B-3, as amended, and KSV Restructuring Inc. (“KSV”) consented to act as proposal trustee.
2. Subsequently, pursuant to an order of the Court of King’s Bench of Alberta (the “Court”) dated March 23, 2026 (the “**Receivership Order**”), KSV was appointed receiver and manager (the “**Receiver**”), without security, of all of the assets, undertakings and property (the “**Property**”) of the Debtor acquired for, or used in relation to the business carried on by the Debtor. 3. The principal assets of the Debtor are its property, plant and equipment situated in Alberta and British Columbia and utilized in its operations, consisting primarily of oil and gas equipment.
