 - 1. I am counsel to 4723718 Nova Scotia Limited (the "Lender"). As such, I have personal knowledge of the matters deposed to in this Affidavit, except where stated to be based on information and belief, in which case, I verily believe the same to be true.
 - 2. I state in this Affidavit the source of any information that is not based on my own personal knowledge, and I state my belief of the source.

I. ESCROW FUNDS:

- Pursuant to a confidential escrow agreement dated June 22, 2025, Cox & Palmer has
 received escrow funds in the amount of \$8,000,000.00 (the "Escrow Funds") which has
 been deposited to the firm's trust account, in its capacity as escrow agent (the "Escrow
 Agreement").
- 4. I am informed by the Lender and do verily believe that an additional amount of \$380,000.00 (the "Top Up Amount") is being wired to our firm from 4725748 Nova Scotia Limited also as lender to the Applicants and it is anticipated that the funds will be received on or before 25 June 2025, for a total of \$8,380,000.00 which will be available for disbursement in accordance with the Escrow Agreement and a second escrow agreement between 4725748 Nova Scotia Limited as lender, the Applicants and Cox & Palmer as escrow agent.
- 5. Attached hereto as **Exhibit "A"** is a copy of Cox & Palmer's trust account ledger evidencing its receipt and holding of the Escrow Funds.

Pursuant to the escrow agreements, the only outstanding material condition for the release
of the Escrow Funds and Top Up Amount is the issuance of the CCAA Termination Order
presently being sought by the Applicants.
