THIS COURT ORDERS that effective as of the date that the Receiver files a certificate in the form attached as Schedule "A" (the "Receiver's Discharge Certificate") certifying that the Recommended Transaction (as defined in the Report) has closed and all post-closing matters have been completed, the Receiver shall be discharged as Receiver of the undertaking, property and assets of the Debtor, provided however that notwithstanding its discharge herein, the Receiver shall continue to have the benefit of the provisions of all Orders made in this proceeding, including all approvals, protections and stays of proceedings in favour of Duff & Phelps Canada Restructuring Inc. in its capacity as Receiver.

THIS COURT ORDERS AND DECLARES that effective as of the date that the Receiver files the Receiver's Discharge Certificate, Duff & Phelps Canada Restructuring Inc. shall be released and discharged from any and all liability that Duff & Phelps Canada Restructuring Inc. then has or may thereafter have by reason of, or in any way arising out of, the acts or omissions of Duff & Phelps Canada Restructuring Inc. while acting in its capacity as Receiver herein, save and except for any gross negligence or wilful misconduct on the Receiver's part.
