To: Creditors of Claireville Property Holdings Inc. (the "Company")

We are writing to advise that on July 2, 2021, the Company commenced restructuring proceedings by filing a Notice of Intention to Make a Proposal ("NOI") pursuant to the *Bankruptcy and Insolvency Act* ("BIA"). A copy of the NOI and a preliminary list of creditors is attached. KSV Restructuring Inc. has been appointed as the proposal trustee under the NOI (the "Proposal Trustee"). Although the NOI proceeding is pursuant to the BIA, it is important to note that the Company is <u>not</u> bankrupt.

The principal purpose of these proceedings is to create a stabilized environment to provide the Company with an opportunity to refinance or otherwise deal with its principal secured obligations and prepare a restructuring plan for creditors which would be formulated in the context of a proposal to be filed in due course.

At present, creditors are not required to file a proof of claim. The Proposal Trustee will provide you with further information and a proof of claim form at a later date.

During these restructuring proceedings:

- no person may terminate or amend any agreement, including a security agreement, with the Company, or claim an accelerated payment, or a forfeiture of the term, under any agreement, including a security agreement, by reason only that the Company is insolvent or by reason of the filing of the NOI, pursuant to Section 65.1(1) of the BIA;
- no creditor has any remedy against the Company or its property or shall commence or continue any action, execution, or other proceedings for the recovery of a claim against the Company or its property, pursuant to Section 69.1(1) of the BIA; and
- the Company intends to pay for any goods or services supplied to it after July 2, 2021. Suppliers should discuss directly with their usual Company representative the terms of payment for goods and/or services they provide to the Company. If any issues arise, the Proposal Trustee is available to assist.
