A. CLAIMS PROCEDURE

By Order of the Ontario Superior Court of Justice (Commercial List) ("Court") made **March 21, 2011** ("Claims Procedure Order"), as amended on **March 25, 2011**, RSM Richter Inc., the Court appointed receiver ("Receiver") of the Debtors, has been authorized to conduct a claims procedure (the "Claims Procedure").

The Claims Procedure is intended for any Person with (i) any claims of any kind or nature whatsoever, against the Debtors, that arose on or prior to **March 17, 2010**, whether such claims are unliquidated, contingent or otherwise; and (ii) any claim arising after **March 17, 2010** as a result of the restructuring, termination, repudiation or disclaimer of any lease, contract, employment agreement or other agreement (collectively, the "Claims").

In accordance with the Claims Procedure, the Receiver is sending to all known potential claimants a Proof of Claim form (as defined in the Claims Procedure Order). This package includes:

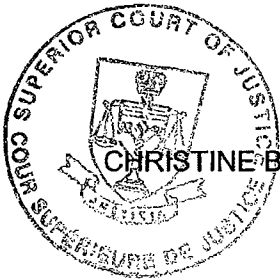

AMENDED ORDER

THIS MOTION made by RSM Richter Inc., in its capacity as Receiver in these proceedings (the "**Receiver**"), for the relief set out in the Notice of Motion dated March 15, 2011, was heard this day at 330 University Avenue, Toronto, Ontario.

ON READING the Notice of Motion, filed, and the Eleventh Report of the Receiver dated March 15, 2011 (the "**Report**") and on hearing submissions from counsel for the Receiver, and others:

The Receiver

1. THIS COURT ORDERS that the Receiver, in addition to its prescribed rights and obligations as set out in the prior Orders of this Honourable Court in this proceeding, is hereby authorized and empowered to take such other actions and fulfill such other roles as are contemplated by this Order.

Definitions

2. THIS COURT ORDERS that the following terms shall have the meanings set out herein where used in this Claims Procedure:

- (a) **"Business Day"** means a day, other than Saturday, Sunday or a statutory holiday, on which chartered banks are generally open for business in Toronto, in the Province of Ontario, Canada;
- (b) **"Claim"** or **"Claims"** includes any right or claim of any person, against any or all of the Debtors, whether or not asserted, in connection with any indebtedness, liability or obligation of any kind, and any interest that may accrue thereon for which there is an obligation to pay, and costs which such person would be entitled to receive pursuant to the terms of any contract with such person, by reason of the commission of a tort (intentional or unintentional), any breach of duty (including, without limitation, any legal, statutory, equitable or fiduciary duty), the repudiation of any contracts or other agreements pursuant to the restructuring, any right of ownership of or title to property or assets or to a trust or deemed trust (statutory, express, implied, resulting, constructive or otherwise) against any property or assets, whether or not reduced to judgment,

liquidated, unliquidated, fixed, contingent, matured, unmatured, disputed, undisputed, legal, equitable, secured, unsecured, perfected, unperfected, present, future, known, or unknown, by guarantee, surety or otherwise, and whether or not such right is executory or anticipatory in nature, or any right or ability of any person to advance a claim for contribution or indemnity or otherwise with respect to any matter, action, cause or chose in action, whether existing at present or commenced in the future;

- (c) **"Claimant"** means a person asserting a Claim.
- (d) **"Claims Bar Date"** means 5:00 p.m. (Toronto time) on April 20, 2011;
- (e) **"Claims Notice"** means the claim notice attached to this Order as Schedule "B";
- (f) **"Claims Procedure"** means the process set out in paragraphs 3 through 10 of this Order;
- (g) **"Debtors"** means,
 - Robert Mander;
 - Mander Group Inc.;
 - Dunn Street Gallery Inc.;
 - Trafalgar Capital Growth Corp.;
 - Stonebury Inc.;
 - Mand Assets Inc.;
 - FM Market Capital Inc.; and
 - Mander-Walton Market Capital Inc.
 - E.M.B. Asset Group Inc.
- (h) **"Proof of Claim"** means the proof of claim forms attached to this Order as Schedule "A";

- (i) **"Repudiated Contract Claims"** has the same meaning as set out in paragraph 6 of this Order;

Claims Procedure

3. THIS COURT ORDERS that the Receiver shall, on or before March 28, 2011, place an advertisement calling for claims substantially in the form of the Claims Notice in *The Globe and Mail* (national edition) and by posting the Claims Notice on the Receiver's website, www.rsmrichter.com.

4. THIS COURT ORDERS that any document to be delivered pursuant to this Claims Procedure may be personally delivered or delivered by e-mail, registered mail, overnight courier or facsimile transmission. A Claimant and the Receiver shall be deemed to have received any document delivered pursuant to this Claims Procedure on the earlier of one Business Day after such document is forwarded by e-mail, overnight courier or facsimile transmission or four days after such document is forwarded by registered mail.

5. THIS COURT ORDERS that any document, copy thereof, notification or notice required to be provided or delivered under the Claims Procedure shall be so provided or delivered to:

THIS COURT ORDERS that any Claimant must file with the Receiver a Proof of Claim together with supporting documentation in respect of such Claim on or before 5:00 p.m. (Toronto time) on April 20, 2011. For those Claims which relate to contracts repudiated by the Debtors subsequent to the Claims Bar Date (the **"Repudiated Contracts Claims"**) a Proof of Claim may be filed within fifteen days of the delivery of the Notice of Repudiation and the Debtors will include in their Notice of Repudiation reference to this extension of the Claims Bar Date.

7. THIS COURT ORDERS that effective the Claims Bar Date (5:00 p.m. (Toronto time) on April 20, 2011), all Claims, other than those Claims for which a Proof of Claim was filed in accordance with this Order and the Repudiated Contracts Claims, shall be extinguished and forever barred against the Debtors.

8. THIS COURT ORDERS that the Receiver is authorized to use reasonable discretion as to the adequacy of compliance with respect to the manner in which Proofs of Claim are completed and executed, and may, where it is satisfied that a Claim of a Claimant has been adequately filed, waive strict compliance with the requirements of this Claims Procedure as to completion and execution of Proofs of Claim.

9. THIS COURT ORDERS that as soon as possible after the conclusion of the Claims Procedure, the Receiver will report to the Court as to its results.

10. THIS COURT ORDERS that Harvey Chaiton be appointed Claims Officer with respect to the Claims Procedure.


