have been completed to the satisfaction of the Receiver, in substantially the form attached hereto as Schedule "A" (the "**Discharge Certificate**"); and (iv) releasing KSV from certain liabilities, was heard this day at 330 University Avenue, Toronto, Ontario.

ON READING the Second Report and on hearing the submissions of counsel for the Receiver, and such other counsel as were present, no one else appearing for any other person on the service list:

- THIS COURT ORDERS that the time for service of the Notice of Motion and the Motion Record herein is hereby abridged and validated so that this Motion is properly returnable today and hereby dispenses with further service thereof.
- THIS COURT ORDERS that each of the Report of the Proposed Receiver, the First Report and the Second Report be and is hereby approved and the actions and activities of the Receiver described therein be and are hereby approved.
- 3. THIS COURT ORDERS that the Receiver be and is hereby authorized to make distributions from time to time to each of RCF and West Face, or such other person or persons as each may direct, without further Order of this Court, on account of the Debtor's secured indebtedness owing to RCF and West Face for principal, interest and costs up to the amount of such secured indebtedness, in such amounts as RCF and West Face may agree, or pursuant to further order of this Court.

4. THIS COURT ORDERS that the Confidential Appendices to the Second Report be and are hereby sealed until further Order of this Court.

5. THIS COURT ORDERS that upon the Receiver filing the Discharge Certificate, the Receiver shall be discharged as Receiver of the undertaking, property and assets of the Debtor, provided that notwithstanding its discharge herein: (a) the Receiver shall remain the Receiver for the performance of such incidental duties as may be required to complete the administration of the receivership herein; and (b) the Receiver shall continue to have the benefit of the provisions of all Orders made in this proceeding, including all approvals, protections and stays of proceedings in favour of KSV in its capacity as the Receiver.

7. THIS COURT ORDERS AND DECLARES that, upon the Receiver filing the Discharge Certificate, KSV is hereby released and discharged from any and all liability that it now has or may hereafter have by reason of, or in any way arising out of, its act or omissions while acting in its capacity as Receiver herein, save and except for any gross negligence or wilful misconduct on the Receiver's part. Without limiting the generality of the foregoing, KSV is hereby forever released and discharged from any and all liability relating to matters that were raised, or which would have been raised, in the within receivership proceedings, save and except for any gross negligence or wilful misconduct on the Receiver's part.
