Subject: First Nickel Inc.

As you are aware, pursuant to an order (the "Receivership Order") of the Ontario Superior Court of Justice (Commercial List) (the "Court") dated August 20, 2015, KSV Kofman Inc. was appointed as receiver (in such capacity, the "Receiver") of First Nickel Inc.

Pursuant to Paragraph 23 of the Receivership Order, the Court ordered, amongst other things, that the E-Service Protocol of the Commercial List shall be approved and adopted in these proceedings. Pursuant to the E-Service Protocol, the Receiver is sending this email to identify itself as the "E-Service List Keeper" and to advise that: (i) you have been placed on the E-Service List; (ii) court documents will be validly served upon proposed stakeholders by email; and (iii) any stakeholder on the E-Service List may serve court documents on any other stakeholder on the E-Service List in accordance with the E-Service Protocol.
