THIS MOTION, made by KSV Kofman Inc., in its capacity as Court-appointed monitor (in such capacity, the "**Monitor**") of 27 Anglin Development Inc. and 29 Anglin Development Inc. (together, the "**Anglin Applicants**") pursuant to the *Companies' Creditors Arrangement Act*, R.S.C. 1985, c. C-36, as amended (the "**CCAA**") was heard this day at 330 University Avenue, Toronto, Ontario.

ON READING the Notice of Motion and the Monitor's Fifth Report dated April 26, 2019 (the "**Fifth Report**"), together with the appendices thereto, and on hearing the submissions of counsel for the Monitor and such other counsel as were present, no one appearing for any other

person on the service list, although properly served as appears from the affidavit of Aiden Nelms sworn April 26, 2019, filed,

1. **THIS COURT ORDERS** that following the delivery of the Monitor's Certificate contemplated by the Anglin Approval and Vesting Order granted on the date hereof, the Monitor is authorized and directed to:

- (a) first, make one or more distributions to pay the commission owing to TD Cornerstone Commercial Realty Inc., being 1.75% of the sale price of the Anglin Properties (as defined in the Fifth Report);
- (b) second, make one or more distributions to pay in full all of the property tax arrears relating to the Anglin Properties; and
- (c) third, make one ore more distributions of all remaining proceeds to Home Trust Company, or as it may direct, up to the amount owing under its registered mortgages on the Anglin Properties.
