UPON BEING ADVISED that the parties consent to the return date set out herein and the schedule of all steps to be taken prior to that date,

1. **THIS COURT ORDERS** that the Debtor's Motion and Ferina's Motion shall be heard together on March ³¹~~23~~, 2020. The return date for the Debtor's Motion is pre-emptory to the Debtor.
