JUDICIAL NOTES:

Conway J. Endorsement

The Receiver seeks orders with respect to the Stoney Creek and Major Mackenzie properties, as well as certain other ancillary orders. The orders are unopposed.

For the Stoney Creek property, the Receiver seeks an approval and vesting order (AVO). For the Major Mackenzie property, the Receiver seeks approval of a stalking horse bid, with a process to see if a superior bid can be obtained.

I am satisfied from the Receiver's Fifth Report that the *Soundair* principles have been met in both cases and that the orders for both properties should be granted.

I am also satisfied that the other ancillary relief should be granted, including the production order with respect to non-privileged information, and the sealing order for the confidential appendices (on the terms set out in the ancillary order). The Sierra Club/Sherman Estates test for sealing has been met. Counsel for the Receiver is directed to file a hard copy of the confidential appendices with the court in a sealed envelope with a copy of this endorsement and the signed orders.

The request for approval of the Receiver's fees and disbursements has been adjourned to a hearing <u>before me</u> <u>on September 13, 2022 at 10:30 a.m. for 15 minutes (confirmed with the CL office)</u> to give stakeholders a longer period to review the fees and disbursements.
