To: Creditors of 999 Gold Depot (Canada) Limited (“999 Gold Depot”)

On April 30, 2026, 999 Gold Depot commenced restructuring proceedings by filing a Notice of Intention to Make a Proposal (“**NOI**”) pursuant to Section 50.4(1) the *Bankruptcy and Insolvency Act (Canada)*, R.S.C. 1985, c. B-3 (“**BIA**”) and KSV Restructuring Inc. was appointed as Proposal Trustee. A copy of the NOI and a preliminary listing of creditors is attached. All information pertaining to the proceedings will be posted to the Proposal Trustee’s website at <https://www.ksvadvisory.com/experience/insolvency-cases>.

Although the NOI proceeding is pursuant to the BIA, it is important to note that 999 Gold Depot is not bankrupt. The principal purpose of the NOI proceeding is to allow for a stay of proceedings to allow 999 Gold Depot to restructure debts to Canada Revenue Agency.

At present, creditors are not required to file a proof of claim. The Proposal Trustee will provide you with further information and a proof of claim form at a later date.

During the restructuring proceedings:

- no person may terminate or amend any agreement with 999 Gold Depot, or claim an accelerated payment, or a forfeiture of the term, under any agreement with 999 Gold Depot, by reason only that 999 Gold Depot is insolvent or by reason of the filing of the NOI, pursuant to Section 65.1(1) of the BIA;
- no creditor has any remedy against 999 Gold Depot or its property or shall commence or continue any action, execution, or other proceedings against 999 Gold Depot, pursuant to Section 69.1(1) of the BIA; and
- to the extent applicable, suppliers should discuss directly with their usual 999 Gold Depot representative the terms of payment for goods and/or services that they provide to 999 Gold Depot.
