- 3. An Order authorizing and directing the Debtors and the Proposal Trustee to take all actions and steps necessary or appropriate to implement and complete the Amended Proposal.
- 4. - (c) A Notice of Hearing dated March 10, 2010, giving notice of this motion, and the Report of the Proposal Trustee dated March 10, 2010, was sent on March 10, 2010 to the Official Receiver and each of the Debtors' creditors.
- (d) This Notice of Application and the Supplemental Report of the Proposal Trustee was also filed with the Official Receiver on March 23, 2010.
- (e) Section 59 of the *Bankruptcy and Insolvency Act*, R.S.C. 1985, c. B-3, as amended.
