C-44, as amended (the "**CBCA**"), for an order, among other things, nullifying and voiding the dissolution of the Applicants, was heard this day by judicial videoconference via Zoom.

**ON READING** the Second Supplement to the Fifth Report of KSV Restructuring Inc, the monitor of the Applicants (in such capacity, the "**Monitor**"), dated November 17, 2025 (the "**Supplemental Report**"), and on hearing the submissions of counsel for the Applicants, counsel for the Monitor, counsel to Corporations Canada, and such other counsel appearing on the Participant Information Form, no one appearing for any other person on the service list, although properly served as appears from the affidavit of David Im, filed,

**DEFINED TERMS**

1. **THIS COURT ORDERS** that capitalized terms used in this Order and not otherwise defined herein shall have the meanings ascribed to them in the Supplemental Report, as applicable.

## **SERVICE**

2. **THIS COURT ORDERS** that the time for service of the Notice of Motion and the Supplemental Report is hereby abridged and validated so that this motion is properly returnable today and hereby dispenses with further service thereof.

## **CORPORATE EXISTENCE**

3. **THIS COURT ORDERS** that the Certificates of Dissolution issued by the Director appointed under the CBCA on October 25, 2025 and November 2, 2025 in respect of Hakim Optical Laboratory Limited and Lawrence Ophthalmic Lab Inc., respectively, are cancelled pursuant to s. 265.1 of the CBCA, *nunc pro tunc*.

4. **THIS COURT ORDERS** that, upon submission of this Order and the required fees, Corporations Canada is hereby directed to immediately take such administrative actions as may be necessary to affirm and to the extent necessary reinstate the corporate existence and validity of all Applicants in all Corporations Canada systems and records without the need for any further action by or on behalf of the Applicants or the Monitor, and without cost to the Applicants.

5. **THIS COURT DECLARES** that the corporate existence and validity of the Applicants is affirmed *nunc pro tunc*.


## **GENERAL**
