ORDER (Stay Extension)

Before the Honourable Justice Keith in chambers:

UPON the Applicants applying for relief under the *Companies Creditors Arrangement Act*, R.S.C. 1985, c. C-36, as amended (the "**CCAA**") in respect of the Respondents (the "**Companies**");

AND UPON such relief being granted by an order dated March 13, 2024, amended and restated by order dated March 22, 2024, which, among other things, appointed KSV Restructuring Inc. as CCAA Monitor (the "**Monitor**"), and, now or in the future, the Monitor applies for other relief under the CCAA as may be sought on notice of motion;

AND UPON the Monitor seeking additional relief including:

1. An extension of the current Stay Period to the new Stay Extension Date of December 12, 2025, as defined in para. 1.1(d)(i) of the Eighth Report of the Monitor dated June 13, 2025 (the "Monitor's Eighth Report");

2. Approving the Monitor's Eighth Report and the Monitor's activities described therein.

AND UPON being advised that proper notice was provided to the persons identified in the Service List attached as Schedule "A" to the Notice of Motion herein:

AND UPON no person or party opposing the relief sought;

AND UPON reviewing the materials herein and hearing submissions of the Monitor and its counsel;

NOW THEREFORE THE FOLLOWING IS ORDERED AND DECLARED

Service and Definitions

- 1. The service of the notice of motion in chambers and the supporting documents is hereby deemed adequate notice so that the motion is properly returnable today and further service thereof is hereby dispensed with.
- 2. Service of this Order is permitted at any time and place and by any means whatsoever.
- 3. All capitalized terms used in this Order not defined herein shall have the meanings ascribed to them in the Monitor's Eighth Report.

Effective Time

4. This Order and all of its provisions are effective as of 12:01 a.m. (Halifax time) on the date of this Order.

Extension of the Stay Period

5. The Stay Period is hereby extended to December 12, 2025.

Approval of the Monitor's Report and Activities

6. The Monitor's Eighth Report, and the activities of the Monitor described therein, are hereby approved, provided, however, that only the Monitor, in its personal capacity and with respect to its own personal liability, shall be entitled to rely upon or utilize in any way such approval.

Update on Real Properties

7. The Monitor shall deliver a letter to the Court on or before September 19, 2025, providing an update on the status of the marketing and sale of the Real Properties.

General

- 8. This Order shall have full force and effect in all provinces and territories in Canada.
- 9. The aid and recognition of any Court, tribunal, regulatory or administrative body in Canada, the United States of America or elsewhere, to give effect to this Order and to assist the Companies, the Monitor and their respective agents in carrying out the terms of this Order. All Courts, tribunals, regulatory and administrative bodies are hereby respectfully requested to make such orders and to provide such assistance to the Companies and the Monitor as may be necessary or desirable to give effect to this Order, to grant representative status to the Monitor or the authorized representative of the Companies in any foreign proceeding, to assist the Companies and
