The principal asset of IRRC is a used motor oil feedstock modular refinery located on 49.39 acres of land in the Regional Municipality of Bone Creek No. 108, in southwest Saskatchewan (the "Echo Refinery"). The Echo Refinery utilizes used motor oil feedstock to produce refined petroleum products such as naphtha, gasoline and kerosene.
