## To: Creditors of Infarm Indoor Urban Farming Canada Inc. ("Infarm")

We are writing to advise you that on October 26, 2023, Infarm commenced restructuring proceedings by filing a Notice of Intention to Make a Proposal ("NOI") pursuant to the *Bankruptcy and Insolvency Act* ("BIA"). A copy of the NOI and a preliminary listing of creditors is attached. KSV Restructuring Inc. has been appointed as the Licensed Insolvency Trustee under the NOI (the "Trustee").

Although the NOI proceeding is pursuant to the BIA, it is important to note that Infarm is not bankrupt. The principal purpose of the NOI proceeding is to allow for a stay of proceedings to allow Infarm to consider various restructuring options.

At present, creditors are not required to file a proof of claim. The Trustee will provide you with further information and a proof of claim form at a later date.

During the restructuring proceedings:

- no person may terminate or amend any agreement with Infarm, or claim an accelerated payment, or a forfeiture of the term, under any agreement with Infarm, by reason only that Infarm is insolvent or by reason of the filing of the NOI, pursuant to Section 65.1(1) of the BIA;
- no creditor has any remedy against Infarm or its property or shall commence or continue any action, execution, or other proceedings against Infarm, pursuant to Section 69.1(1) of the BIA; and
- to the extent applicable, suppliers should discuss directly with their usual Infarm representative the terms of payment for goods and/or services that they provide to Infarm.
