# Notice and Statement of the Receiver (Subsection 245(1) and 246(1) of the *Bankruptcy and Insolvency Act*)

## IN THE MATTER OF THE RECEIVERSHIP OF JMD-M CANADA INC.

- 1. Pursuant to an order of the Ontario Superior Court of Justice (Commercial List) (the "Court") dated March 31, 2023 (the "Receivership Order"), KSV Restructuring Inc. ("KSV") was appointed receiver (the "Receiver"), without security, of all of the assets, undertakings and properties (the "Property") of JMD-M Canada Inc. (the "Company") acquired for, or used in relation to a business carried on by the Company.
- 2. The Company's principal asset is a four-acre parcel of real estate in the City of Kawartha Lakes (the "Real Property") on which it operates a gas station and convenience store. There is also a commercial unit on the Real Property which is leased to an auto repair shop. The Receiver is working to obtain further information with respect to the Company.
- 3. The following information relates to the receivership of the Company:

Head office: 70 Falaise Road, Scarborough, ON

Business location: 605 Highway 7, Oakwood (City of Kawartha Lakes), ON

Principal line of business: Owner of Real Property and operator of gas station and

convenience store.

#### 4. Secured Creditors

The Company's known secured creditors are:

- Stercus Accidit Investment Corp. in respect of a first-priority mortgage on the Real Property in the principal amount of \$1.5 million;
- Sreelu Consulting Inc., John Paul Kancherla, Balaji Ramu Dhuchetty, Likith Santosh Ambati, Keerthi Chowdary Sukhavast and Vasu Karkarla in respect of a second mortgage on the property in the principal amount of \$1 million; and
- City of Kawartha, in respect of municipal taxes and interest in the amount of \$6,409.07.

#### 5. Other Creditors

At this time, the Receiver has limited information on the extent of other unsecured claims against the Company. Based on information provided by the Company, a listing of potential unsecured creditors has been compiled and is attached as Appendix "A". As the Receiver becomes aware of any additional unsecured creditors, it will provide a copy of this notice to those parties. #### 6. Estimated Realization and Sale Process

The principal purpose of the receivership proceedings is to identify, secure and realize on the Real Property. The Receivership Order authorized the Receiver to enter into a listing agreement with Keller Williams Advantage Realty, Brokerage. The Real Property is presently listed for sale for \$4.29 million. Any transaction for the Real Property will be subject to Court approval. The outcome of the realization process will determine the amount available for distribution to the Company's creditors.
