ENDORSEMENT OF MADAM JUSTICE STEELE:

- [1] The Receiver, KSV Restructuring Inc. ("KSV"), brings a motion seeking, among other things, an approval and vesting order to approve the stalking horse transaction, authorization to terminate and disclaim agreements of purchase and sale for the purchase of any or all of the debtor's real property, and authorization to make a distribution to Kingsett.
- [2] On May 30, 2024, the court issued an order approving a sale process in respect of the debtors' property and a stalking horse agreement of purchase and sale. The Receiver implemented the sale process, which did not result in any letters of interest being submitted by the deadline. The Receiver seeks to implement the transaction contemplated under the stalking horse agreement.

[3] The motion is adjourned. It will be heard on August 16, 2024 at 11 am (hours) and on September 17, 2024 at 11 am (2 hours).

- [4] The motion was booked for an hour, which is not sufficient time for a contested matter.
- [5] The Receiver's materials were late served.
- [6] The Receiver's motion is contested by (i) the respondents, Mapleview Developments Ltd., Pace Mapleview Ltd. and 2552741 Ontario Inc.; and (ii) certain lien claimants.
- [7] The respondents' counsel was just retained yesterday. The respondents have not yet filed their materials.
- [8] One of the lien claimants, Fuller Landau Group Inc., Receiver of Quality Sterling Group Inc., filed materials opposing the amount of the proposed distribution to Kingsett. The QSG Receiver seeks a hold back of the full amount of the lien claims. At the proceeding today, two other lien claimants indicated that they also intend to file materials in opposition of the proposed distribution to Kingsett.

- [9] The portion of the motion pertaining to the approval of the sale and AVO is contested by the respondents. This motion is urgent given that the outside date in the purchase agreement is August 31, 2024. The Receiver indicated that the final orders must be issued by August 21, 2024. This motion shall be heard on August 16, 2024 at 11 am (2 hours). The schedule for delivery of materials is as follows:
 - a. Responding materials by August 7, 2024;
 - b. Reply by August 9, 2024.
- [10] The contested portion of the motion pertaining to the proposed distribution to Kingsett and potential priorities issue shall be heard on September 17, 2024 at 11 am (2 hours). The schedule for delivery of materials is as follows:
 - a. Responding materials by August 15, 2024; and
 - b. Reply by August 22, 2024.
