This is a complex CCAA proceeding but solid progress is being made. The claims process is largely finalized. Some more time is needed to work out claims of CRA. The Monitor advises that all of the arm's length claims have been sorted out with the exception of CRA. I understand the issues as regards CRA and am confident that those will be either worked out or a process to resolve outstanding issues agreed upon before the requested stay extension comes back. I have reviewed the fees submitted for approval – no stakeholder has raised an objection and they appear fair and reasonable in the circumstances of a case with as many moving parts as this one has had. They shall be approved.
