1. **THIS COURT ORDERS** that 1000 Ontario pay to SHCL costs of \$12,000.00, inclusive of HST and disbursements, within 30 calendar days of the date of this Order.
2. **THIS COURT ORDERS** that 1000 Ontario pay to the Trustee costs of \$50,000.00, inclusive of HST and disbursements, within 30 calendar days of the date of this Order.
3. **THIS COURT ORDERS** that, notwithstanding Rule 59.05, this Order is effective from the date it is made, and is enforceable without any need for entry and filing.
