ORDER

(“**1000 Co.**”) and its representatives or agents from interfering with the Company’s business operations, including prohibiting such parties from communicating with the Company’s employees and attending at the Company’s two business premises, until further order of the Court, was heard this day virtually via video conference.

ON READING the Notice of Motion of the Company, the Fourth Report of the Proposal Trustee, KSV Restructuring Inc., dated November 1, 2022 and on hearing the submissions of counsel for the Proposal Trustee, for the Company and for 1000 Co.,

SERVICE

1. **THIS COURT ORDERS** that the time for service of the Company's Notice of Motion and the Fourth Report is hereby abridged and validated, and the manner of service thereof is hereby validated, so that this motion is properly returnable today, and hereby dispenses with further service thereof.

RESTRAINING 1000296348 ONTARIO INC.

2. **THIS COURT ORDERS** that, until further order of the Court,
- (a) 1000 Co. and its representatives or agents are restrained from interfering with the Company's business operations;
 - (b) 1000 Co. and its representatives or agents are prohibited from communicating with the Company's employees; and
 - (c) any attendances by 1000 Co. and its representatives or agents at the Company's two business premises at 23 Railway Street, Paris, Ontario and 245 West Beaver Creek Rd, Unit 2, Richmond Hill, Ontario, shall be coordinated through the Proposal Trustee or its legal counsel.
3. **THIS COURT ORDERS** that 1000 Co. and its representatives or agents shall take all necessary steps for the restoration of power at 23 Railway Street, Paris, Ontario.

COSTS

4. **THIS COURT ORDERS** that the costs of this hearing shall be reserved and dealt with by further order of the Court.
