**ORDER**

**THIS MOTION**, made by the plaintiff for an order for the relief sought herein, was heard on March 3, 2026 and adjourned to a further hearing on this day, in each case via remote videoconference at 330 University Ave., Toronto, Ontario.

**ON READING** the motion record, factum, supplementary factum and costs outline filed by the plaintiff, the factum filed by Andrew David Chang-Sang, and on hearing the submissions

of counsel for the plaintiff and for Andrew David Chang-Sang, no one appearing for any of Myron LLC, DECS Limited, or DECS Trust by its trustee DECS Limited, all of whom have been duly served with the statement of claim in this proceeding and noted in default,

1. **THIS COURT ORDERS** that the service of the Notice of Motion and the Motion Record is hereby validated so that this Motion is properly returnable today and hereby dispenses with further service thereof.


2. **THIS COURT GRANTS** judgment against Myron LLC, DECS Limited, and DECS Trust by its trustee DECS Limited (collectively, the “**Responding Parties**”), jointly and severally, for the following amounts, payable forthwith:

- (a) damages in an amount sufficient to purchase \$1,810,000 in United States Dollars at a bank in Ontario listed in Schedule I to the *Bank Act (Canada)* at the close of business on the first day on which the bank quotes a Canadian dollar rate for purchase of the foreign currency before the day payment of the obligation is received by the plaintiff;
- (b) damages in an amount sufficient to purchase \$1,200,000 in United States Dollars at a bank in Ontario listed in Schedule I to the *Bank Act (Canada)* at the close of business on the first day on which the bank quotes a Canadian dollar rate for purchase of the foreign currency before the day payment of the obligation is received by the plaintiff;
- (c) pre-judgment interest under the *Courts of Justice Act* on the amount referenced in paragraph 2(a) above, in an amount sufficient to purchase \$213,926.83 in United States Dollars at a bank in Ontario listed in Schedule I to the *Bank Act (Canada)* at the close of business on the first day on which

the bank quotes a Canadian dollar rate for purchase of the foreign currency before the day payment of the obligation is received by the plaintiff;

- (d) pre-judgment interest under the *Courts of Justice Act* on the amount referenced in paragraph 2(b) above, in an amount sufficient to purchase \$62,990 in United States Dollars at a bank in Ontario listed in Schedule I to the *Bank Act* (Canada) at the close of business on the first day on which the bank quotes a Canadian dollar rate for purchase of the foreign currency before the day payment of the obligation is received by the plaintiff;
- (e) costs on a partial indemnity scale, fixed at \$25,194.60 on a partial indemnity scale inclusive of HST and disbursements.

THIS ORDER BEARS INTEREST at 4.0% per annum commencing on the date hereof.
