ENDORSEMENT OF JUSTICE:

1. KSV Restructuring Inc. (the “Receiver”) is the court-appointed receiver and manager of Productivity Media Inc. (PMI), Productivity Media Income Fund I LP (PMIF), Productivity Media Lending Corp. I (PMLC), and 8397830 Canada Inc. (839 Canada) in the receivership brought under Court File No. CV-24-00730869-00CL (the Receivership), and in that capacity the plaintiff in the related civil action under Court File No.CV-24-00731806-00CL (the Fraud Recovery Action).
2. The Receiver has brought two motions that were returnable on June 20, 2025, one in Receivership proceeding and one in the Fraud Recovery Action. At the request of the Receiver and certain stakeholders in attendance today, those motions have been adjourned to allow more time for affected stakeholders to consider their positions and respond, if they wish to do so.
3. These motions will now be heard on July 15, 2025 in person commencing at 11:00 a.m. Two hours has been reserved for this hearing.
4. The following pre-hearing timetable shall be adhered to for these motions:
 - a. By June 20, 2025: The Receiver shall deliver its motion record(s) indicating the new hearing date, together with a copy of this endorsement.
 - b. By June 27, 2025: Any stakeholder who expects to oppose any aspect of the relief sought by the Receiver shall deliver to the service list a statement of position indicating what aspect(s) of the relief is opposed and the grounds of opposition.
 - c. By July 3, 2025: The Receiver shall deliver its fresh amended factum for these motions (taking into account, if appropriate, the stated positions(s) and grounds of any opposition). Any party supporting the Receiver’s motions shall also deliver their written submissions by this same date.
 - d. By July 3, 2025: Any party who has indicated they will be opposing either or both of these motions and who wishes to ask questions of the Receiver shall deliver their written questions to the Receiver.
 - e. By July 10, 2025: The Receiver shall deliver its written responses to any questions from stakeholders received on July 3, 2025.

- f. By July 14, 2025 at 2:30 p.m.: Any party still intending to oppose either of these motions shall deliver their written submissions in opposition.
 - g. All material shall be uploaded into the appropriate hearing bundle in Case Center as soon as the bundle is open (which should be the week prior to the hearing) and then materials shall be uploaded upon being served after that. It is imperative that all materials shall have been served, filed and uploaded into the appropriate hearing bundle in Case Center by no later than 2:30 p.m. on July 14, 2025.
5. If there is a problem with meeting any of these timetabled steps, a case conference shall be promptly arranged to address any timing concerns.
