
ORDER

THIS MOTION made by the Applicant, Swinderpal Singh Randhawa (“**Paul**”), for an Order that Rana Partap Singh Randhawa (“**Rana**”) pay certain amounts to the Applicant and to KSV Restructuring Inc. as receiver and manager without security, of all of the assets, undertakings and properties of the Respondent corporate entities (collectively, “**RGC**”) acquired for, or used in relation to a business carried on by RGC (the “**Receiver**”);

ON READING Paul’s Notice of Motion and the Consent of the parties:

THIS COURT ORDERS THAT:

1. Capitalized terms not defined in this Order shall have the meaning ascribed to them in my Order dated May 26, 2021.
2. Rana shall pay Paul \$150,000, inclusive of disbursements and HST (the "**Payment**"), in full and final satisfaction of Paul's claims to the funds he previously posted with the Receiver, being \$100,000 on May 25, 2021 and \$50,000 on July 19, 2021, for a total of \$150,000, all in respect of the Investigation Mandate.
3. The Payment shall be made in accordance with the following payment schedule:
 - i. Rana shall pay Paul \$75,000, representing the first half of the Payment, within 45 days of the date of this Order; and
 - ii. Rana shall pay Paul \$75,000, representing the second half of the Payment, within 60 days of the date of this Order.
4. The balance of the relief sought in the Notice of Motion will be adjourned *sine die*, without prejudice to any party's positions with respect to that relief.
5. No costs shall be payable in connection with this Order.
