SUPPLEMENTARY AFFIDAVIT OF MUZAMMIL KODWAVI, SWORN OCTOBER 18, 2022

I, MUZAMMIL KODWAVI, of the City of Richmond Hill, in the Province of Ontario, MAKE OATH AND SAY:

- 1. I am the Chief Operating Officer of the Respondent, Sunrise Acquisitions (Hwy 7) Inc. ("Sunrise") and as such, have knowledge of the matters to which I hereinafter depose. Where I do not have such knowledge, I have identified the source of my information and verily believe that information to be true.
- 2. I make this affidavit in response to the Motion Record of the Court-Appointed Receiver, KSV Restructuring Inc. (the "Receiver"), dated August 5, 2022 and to supplement my affidavit sworn on September 16, 2022 (the "September Affidavit").

Intercompany Transfers and Transfers to the Principals

- 3. Sunrise's counsel, RAR Litigation retained the services of MNP LLP ("MNP") to inspect the financial records of Sunrise and to report on transactions with myself, my partner, Mr. Sajjad Hussain ("Mr. Hussain") and the related parties. MNP rendered a report dated October 18, 2022 (the "MNP Report"). Attached hereto and marked as **Exhibit "A"** to my affidavit, is a true copy of the MNP Report.
- 4. I make the following observations in respect of the findings in the MNP Report in comparison to the Receiver's review and commentary of the financial records of Sunrise:
 - a. The Receiver has failed to account for payments made to myself, Mr. Hussain, and the related parties for legitimate purposes including, but not limited to:
 - i. payments made by Sunrise to Mr. Hussain and I on account of capital injections and dividend payments which total \$2,516,092.00;
 - ii. repayments made by Sunrise to Mr. Hussain and I on account of reimbursement for expenses incurred on behalf of Sunrise which total \$4,170,557.00 and salary remuneration paid by Sunrise to Mr. Hussain and I; and
 - iii. repayments made by Sunrise to Mr. Hussain and I on account of reimbursement for certain liabilities incurred by Sunrise for which payment was proffered by Mr. Hussain and I.
 - b. The Receiver's records of funds advanced to the myself, Mr. Hussain, and the related parties does not reconcile with MNP's findings. For example, the Receiver states in the Third Report of the Receiver dated October 20, 2021 (the "Third Report") at paragraph 3.4.4, that the net advances to Sunrise Acquisitions Inc., per the Bank Information is \$30,740.00, whereas according to the MNP Report, the net advances to Sunrise Acquisitions Inc., is \$46,540.00.
 - c. While admittedly the amount identified by MNP is greater, the underlying issue is that the Receiver has clearly not conducted a thorough, complete or accurate review

- of the financial records of Sunrise, such to satisfy any trier of fact that its findings are accurate in support of a claim for judgment totalling nearly \$11,000,000.00.
- d. At paragraph 3.4.5 of the Third Report, the Receiver states that there is a variance of approximately \$10,500,000.00 in the amounts set out in the General Ledger of Sunrise and the information derived from the Bank Information. However, at paragraph 3.2 of the MNP Report, MNP states:

"Based on our review of the Bank Information, most but not all of the Net Payments to and from the Principals and Related Parties of Hwy 7 were recorded in the General Ledger (99.5%)."

e. Again, the stark difference between the Receiver's conclusions and those of MNP in relation to the record of the transfers on the General Ledger for Sunrise reveal that the Receiver's findings are inaccurate.

Recorded and Unrecorded Net Advances

- 5. The MNP Report concludes that the recorded net advances to myself, Mr. Hussain and the related parties total \$5,490,260.00.
- 6. The MNP Report also identifies unrecorded net advances to myself, Mr. Hussain, SH & MK Management Inc., and Sunrise Acquisitions (Bronte) Inc., totalling \$59,345.00.
- 7. I acknowledge that these monies ought to be repaid to Sunrise and will make repayment to Sunrise in the amount of \$5,549,605.00.

Other Assets

8. The MNP Report identifies an amount of \$625,236.00 paid to myself and Mr. Hussain under the category of 'Other Assets'. This amount represents certain liabilities incurred by Sunrise for which payment was made by either myself and Mr. Hussain and the payment of \$625,236.00 represents the reimbursement by Sunrise to myself and Mr. Hussain.

Equity and Dividends

- 9. MNP identifies in Table 3, payments made by Sunrise to myself, Mr. Hussain and Mr. Nayyar Shabbar ("Mr. Shabbar") totalling \$2,516,092.00 in respect of equity repayments and shareholder dividends.
- 10. All payments made by Sunrise to myself, Mr. Hussain and Mr. Shabbar in respect of equity repayments and/or shareholder dividends are legitimate payments.

Expenses

- 11. MNP identifies in Table 3, payments made by Sunrise to myself, Mr. Hussain, Mr. Shabbar, and SH & HK Management Inc. totalling \$4,170,557.00 in respect of reimbursement for expenses incurred on behalf of Sunrise and in respect of salaries paid by Sunrise to Mr. Hussain and I.
- 12. In fact, there is an amount of \$1,400,000.00 that remains due and owing to SH & HK Management Inc. in respect of management services rendered which has not yet been paid and for which Sunrise remains liable.
- 13. All salary payments and reimbursement payments made to myself, Mr. Hussain, Mr. Shabbar, and SH & HK Management Inc. in respect of expenses incurred on behalf of Sunrise are legitimate repayments.

1.0 INTRODUCTION AND BACKGROUND

- 1.1. MNP LLP was retained by RAR Litigation ("Counsel" or the "Client") on behalf of Sunrise Acquisitions (Hwy 7) Inc. in connection with a claim pursued by KSV Advisory Inc. ("KSV").
- 1.2. Sunrise Acquisitions (Hwy 7) Inc. ("Hwy 7")¹ is a single purpose entity² created to manage the Unionvillas housing development and is one of many entities comprising a real estate development group known as Sunrise Homes.
- 1.3. The Unionvillas housing development is a 52-townhome development in Markham, Ontario.
- 1.4. Sunrise Homes is a residential and commercial construction business located in Richmond Hill, Ontario.
- 1.5. Muzammil Kodwavi ("Mr. Kodwavi") and Sajjad Hussain ("Mr. Hussain") are the Principals of Hwy 7 and Sunrise Homes, among other related parties.
- 1.6. Pursuant to a Receivership Order dated June 9, 2021, KSV was appointed as the Receiver and Manager of Hwy 7.
- 1.7. In its report entitled Third Report of the Receiver dated October 20, 2021 (the "KSV Report"), it was reported that Hwy 7 paid Mr. Kodwavi and Mr. Hussain (defined as the "Principals" in the KSV Report) and related companies and persons (defined as "Related Parties" in the KSV Report), a net amount of approximately \$11.4 million based on Hwy 7's Bank Account Information³. In the Second Supplemental to the Third Report of the Receiver, dated August 5, 2022, KSV states that the net payments of \$11.4 million were made without justification.
- 1.8. KSV also reported that Mr. Kodwavi appears to have deliberately attempted to mislead the Receivers investigation by providing inaccurate and incomplete information, including making it appear that the Sunrise Parties (collectively the Principals and the Related Parties) received significantly less money from Hwy 7.
- 1.9. In Section 3.3.4 of the KSV Report, KSV categorizes the net amount paid to the Principals and Related Parties as Net (Advances) per the Bank Information (\$11,361,453) and compares it to Net (Advances) to the Principals and Related Parties per the General Ledger (\$839,206) and calculates a Variance of \$10,522,247.

- 1.10. Based on the above, KSV continues on in Section 3.3.5 of the KSV Report and concludes that \$11.4 million was paid to the Principals and Related Parties, which is approximately \$10.5 million more than the amount recorded in the General Ledger.
- 1.11. KSV further states that the amount paid to the Principals and Related Parties may be higher or lower as it did not have certain bank information for 2015 and 2016 and it had been unable to identify certain receipts and disbursements for 2015 and 2016.
- 1.12. We understand our Report may be used for the purpose of litigation in this matter.

2.0 SCOPE OF ENGAGEMENT

- 2.1. MNP was retained to inspect the financial records of Hwy 7 and to report on the transactions with the Principals and the Related Parties of Hwy 7.
- 2.2. We inspected the financial records of Hwy 7 for the period April 2015 to May 2021 ("**Period of Review**") except where it is noted to be otherwise.
- 2.3. Our procedures related to the financial records of Hwy 7 included the activities described in paragraph 2.4 to 2.10 below.
- 2.4. We reviewed payments by Hwy 7 from its RBC account number 08112 101-892-8 over the period May 2015 to January 2017 and from its CIBC account number 08642-20-60612 over the period January 2017 to May 2021 (collectively referred to as the "Bank Information").
- 2.5. We reviewed accounting entries made in the General Ledger of Hwy 7 over the Period of Review ("General Ledger").
- 2.6. We reviewed supporting documentation for transactions with the Principals and the Related Parties as described in this report.
- 2.7. We reviewed the financial statements of Hwy 7 for the fiscal years ending December 31, 2015 to December 31, 2018. We are advised that financial statements were not prepared for 2019 and 2020.
- 2.8. We reviewed the Third Report of the Receiver dated October 20, 2021 with a focus on pages 6 to 8 (and related analysis) and the Second Supplemental to the Third Report of the Receiver dated August 5, 2022 with a focus on pages 6 to 8 (and related analysis).
- 2.9. We held discussions with Mr. Kodwavi, Chief Operating Officer, Sunrise Homes Inc. and Mr. J. Poopalasingam, Controller, Sunrise Homes Inc.
- 2.10. The list of documents reviewed can be found in Appendix A.

Independence and Objectivity

2.11. This report was prepared in conformity with the Standard Practices for Investigative and Forensic Accounting Engagements of CPA Canada, in doing so, the author acted independently and objectively.

2.12. This Report was authored with the assistance of forensic staff at MNP under the direction and supervision of Stephen Dodd and Rob Fowlie. Rob Fowlie, CPA, CA, CFE is a Partner and Stephen Dodd, MBA, CPA, CMA is a Senior Manager with MNP LLP, a National Canadian accounting and business consulting firm.

Limitations

- 2.13. In undertaking our analysis and preparing our report we note the limitations described below.
- 2.14. We received and reviewed a General Ledger from Hwy 7 for the Period of Review and compared it to the General Ledger attached as Appendix E to the Second Supplemental to the Third Report of the Receiver, dated August 5, 2022, and found the documents to be different. As of the date of this report, we have not undertaken an examination to identify the reasons for differences in the General Ledger documents nor have we sought an explanation from Hwy 7 for the differences.
- 2.15. We requested but did not receive documentation related to the terms and conditions for the Advances between Hwy 7 and the Principals and Related Parties.
- 2.16. We requested but did not receive documentation related to the terms and conditions for Investments made by the Principals and Related Parties in Hwy 7.
- 2.17. We requested but did not receive documentation for certain amounts deposited into the Hwy 7 bank accounts as well as certain cheques withdrawn from the Hwy 7 bank accounts. Where documentation has not been provided, we have relied upon deposit slip descriptions of the parties that are the source of the deposit and general ledger entries to confirm the cheque amounts and payees.

- 2.18. Our report is not intended for general circulation. It should not be reproduced or used for any purpose other than outlined above. We assume no responsibility or liability for losses incurred by any party resulting from the circulation, publication, reproduction or use of the report contrary to the provisions of this paragraph.
- 2.19. Our report is based on the procedures performed as at the date of the report. We reserve the right to review all findings and conclusions and, if we consider it necessary, to revise our report for any information provided subsequent to the date of this report.
- 2.20. Our work does not constitute an audit as defined by CPA Canada.

3.0 SUMMARY OF FINDINGS

3.1. Based on the scope of our review, limitations in scope, restrictions and assumptions as stated in this report, Net Payments⁴ to and from the Principals and Related Parties of Hwy 7 recorded in the Bank Information were as follows:

4.0 DETAILED FINDINGS

A. Muzammil Kodwavi

- 4.1. Based on our review of the Hwy 7 Bank Information, total payments to Mr. Kodwavi were \$6,331,462 over the Period of Review.
- 4.2. Over the same period, deposits from Mr. Kodwavi were \$3,618,302.
- 4.3. As a result of the above, Net Payments to Mr. Kodwavi were \$2,713,160 over the Period of Review.
- 4.4. The General Ledger indicates an amount \$98,004 lower than the Bank Information as a result of 4 transactions in the Bank Information with a Net Payment value of \$98,004 that were not in the General Ledger. As a result, the General Ledger accounts for only \$2,615,156 of the Net Payments of \$2,713,160. These transactions and the reconciliation of the Bank Information to the General Ledger can be found in Schedule 1. See Section 4U for more details
- 4.5. As detailed in Schedule 1, the Net Payments to Mr. Kodwavi over the Period of Review were accounted for as follows in the General Ledger of Hwy 7:

4.6. As shown in Table 3, the Net Payments to Mr. Kodwavi from Hwy 7 have been accounted for and are categorized as Advances, Equity and Dividends, Other Assets, and Expenses.

B. Sajjad Hussain

- 4.7. Based on our review of the Hwy 7 Bank Information, total payments to Mr. Hussain were \$2,477,085 over the Period of Review.
- 4.8. Over the same period, deposits from Mr. Hussain were \$46,248.
- 4.9. As a result of the above, Net Payments to Mr. Hussain were \$2,430,837 over the Period of Review.
- 4.10. The General Ledger indicates an amount \$59,341 lower than the Bank Information as a result of 5 transactions in the Bank Information with a Net Payment value of \$59,341 that were not in the General Ledger. As a result, the General Ledger accounts for only \$2,371,496 of the Net Payments of \$2,430,837. These transactions and the reconciliation of the Bank Information to the General Ledger can be found in Schedule 2. See Section 4U for more details
- 4.11. As detailed in Schedule 2, the Net Payments to Mr. Hussain over the Period of Review were accounted for in the General Ledger of Hwy 7 as follows:

4.12. As shown in Table 3, the Net Payments to Mr. Hussain from Hwy 7 were accounted for and categorized as Advances, Equity and Dividends, Other Assets, and Expenses.

C. SH & MK Management Inc.

- 4.13. SH & MK Management Inc. is a management company created by the Principals, Mr. Hussain and Mr. Kodwavi, to manage the various Sunrise entities.
- 4.14. Based on our review of the Hwy 7 Bank Information, total payments to SH & MK Management Inc. were \$2,197,658 over the Period of Review.
- 4.15. Over the same period, deposits from SH & MK Management Inc. were \$371,608.
- 4.16. As a result of the above, Net Payments to SH & MK Management Inc. were \$1,826,050 over the Period of Review.
- 4.17. The General Ledger indicates an amount \$48,000 lower than the Bank Information as a result of 2 transactions in the Bank Information with a Net Payment value of \$48,000 that were not in the General Ledger. As a result, the General Ledger accounts for only \$1,778,050 of the Net Payments of \$1,826,050. These transactions and the reconciliation of the Bank Information to the General Ledger can be found in Schedule 3. See Section 4U for more details.
- 4.18. As detailed in Schedule 3, the Net Payments to SH & MK Management Inc. over the Period of Review were accounted for as follows:

4.19. Based on discussions with Mr. Kodwavi, we were advised that SH & MK Management Inc. was paid management fees to manage the Hwy 7 project. We have requested the management agreement between Hwy 7 and SH & MK Management Inc. outlining the fees to be paid, but have not received any documentation to date.

- 4.20. The Net Payments to SH & MK Management Inc over the Period of Review were primarily recorded in an account entitled "SH & MK Management Inc.". Journal entries were made in the account at year end that changed the accounting for the Net Payments to Management Fees in 2016 (\$440,700), 2017 (\$452,000), 2018 (\$437,875) and 2019 (\$431,660) for a total of \$1,762,235. After adjusting for an error of \$1,186, the Net Payments of \$1,761,050 have been accounted for as Management Fees.
- 4.21. The transaction for \$17,000 would appear to be an account entry error and has been considered as an Advance recorded in Accounts Payable as a debit.

D. Nayyar Shabbar

- 4.22. Nayyar Shabbar is an individual who invested in Hwy 7 and is a purchaser of a unit in the Unionvillas development.
- 4.23. The initial transactions in the Nayyar Shabbar account that create an investment balance include a non-cash transaction⁸ on June 30, 2016 to debit/increase the value of the investment account by \$300,000 and two deposits totaling \$700,000, for an investment of \$1,000,000⁹. 10
- 4.24. Based on our review of the Hwy 7 Bank Information, total payments to Nayyar Shabbar were \$1,442,312 over the Period of Review.
- 4.25. Over the same period, deposits from Nayyar Shabbar were \$717,870.
- 4.26. As a result of the above, Net Payments to Nayyar Shabbar were \$724,443 over the Period of Review.
- 4.27. As detailed in Schedule 4, the Net Payments to Nayyar Shabbar over the Period of Review were accounted for as follows:

- 4.28. The Accounts Payable transactions have a memo indicating they are for an Interest Payment to Nayyar Shabbar. The transactions only occur in the Accounts Payable GL Account and represent an error in the categorization of the payment.
- 4.29. We requested but did not receive documentation to confirm the investment.

E. Sunrise Homes Ltd.

- 4.30. We are advised that Sunrise Homes Ltd. is a management company that controls single purpose entities on behalf of the two Principals, Mr. Hussain and Mr. Kodwavi.
- 4.31. Based on our review of the Hwy 7 Bank Information, total payments to Sunrise Homes Ltd. were \$687,000 over the Period of Review.
- 4.32. Over the same period, deposits from Sunrise Homes Ltd. were \$73,350.
- 4.33. As a result of the above, Net Payments to Sunrise Homes Ltd were \$613,650 over the Period of Review.
- 4.34. The Net Payments to Sunrise Homes Ltd over the Period of Review were recorded in an account entitled "Sunrise Homes Ltd.". See Schedule 5.
- 4.35. At year end each December 31, the balance of the Sunrise Homes Ltd. account was transferred (together with other Related Party accounts) to an account entitled "Intercompany Transactions". The year-end balance of the Intercompany Transactions account matches the balance of the financial statement worksheets and trial balance provided.
- 4.36. On January 1, the transaction was reversed, returning the balance to Sunrise Homes Ltd. account.

4.37. Other Journal entries have not been made to change the balance of the account or to account for the transactions as an Other Asset, Expense or Equity and, therefore, the Net Payments to Sunrise Homes Ltd. of \$613,650 have been accounted for and categorized as Advances.

F. Sunrise Acquisitions (Bronte) Inc.

- 4.38. Sunrise Acquisitions (Bronte) Inc. is a single purpose real estate development entity that is part of the Sunrise Homes group.
- 4.39. Based on our review of the Hwy 7 Bank Information, total payments to Sunrise Acquisitions (Bronte) Inc. were \$3,266,650 over the Period of Review.
- 4.40. Over the same period, deposits from Sunrise Acquisitions (Bronte) Inc. were \$752,100.
- 4.41. As a result of the above, Net Payments to Sunrise Acquisitions (Bronte) Inc. were \$2,514,550 over the Period of Review.
- 4.42. As detailed in Schedule 6, the Net Payments to Sunrise Acquisitions (Bronte) Inc. over the Period of Review were accounted for as Advances.
- 4.43. The General Ledger indicates Advances owed by Sunrise Acquisitions (Bronte) Inc. to be \$2,489,550, or \$25,000 lower than the Bank Information as a result of 4 transactions in the Bank Information with a Net Payment value of \$25,000 that were not in the General Ledger. These transactions and the reconciliation of the Bank Information to the General Ledger can be found in Schedule 6. See Section 4U for more details.
- 4.44. Accordingly, the Advances owed by Sunrise Acquisitions (Bronte) Inc. to Hwy 7 should be recorded to be \$2,514,550 in the General Ledger.

G. Sunrise Acquisitions (Unionville) Inc.

- 4.45. Sunrise Acquisitions (Unionville) Inc. is a single purpose real estate development entity that is part of the Sunrise Homes group.
- 4.46. Based on our review of the Hwy 7 Bank Information, total payments to Sunrise Acquisitions (Unionville) Inc. were \$1,823,600 over the Period of Review.
- 4.47. Over the same period, deposits from Sunrise Acquisitions (Unionville) Inc. were \$291,500.
- 4.48. As a result of the above, Net Payments to Sunrise Acquisitions (Unionville) Inc. were \$1,532,100 over the Period of Review.

- 4.49. As detailed in Schedule 7, the Net Payments to Sunrise Acquisitions (Unionville) Inc. over the Period of Review were accounted for as Advances.
- 4.50. The General Ledger indicates Advances owed by Sunrise Acquisitions (Unionville) Inc. to Hwy 7 to be \$1,703,100, or \$171,000 higher than the Bank Information as a result of three transactions with a Net Deposit value of \$171,000 in the Bank Information that were not in the General Ledger. These transactions and the reconciliation of the Bank Information to the General Ledger can be found in Schedule 7. See Section 4U for more details.
- 4.51. Accordingly, the Advances owed by Sunrise Acquisitions (Unionville) Inc. to Hwy 7 should be recorded to be \$1,532,100 in the General Ledger.

H. Sunrise Acquisitions (Keswick) Inc.

- 4.52. Sunrise Acquisitions (Keswick) Inc. is a single purpose real estate development entity that is part of the Sunrise Homes group.
- 4.53. Based on our review of the Hwy 7 Bank Information, total payments to Sunrise Acquisitions (Keswick) Inc. were \$1,912,975 over the Period of Review.
- 4.54. Over the same period, deposits from Sunrise Acquisitions (Keswick) Inc. were \$653,500.
- 4.55. As a result of the above, Net Payments to Sunrise Acquisitions (Keswick) Inc. were \$1,259,475 over the Period of Review.
- 4.56. As detailed in Schedule 8 the Net Payments to Sunrise Acquisitions (Keswick) Inc. over the Period of Review were accounted for as Advances.
- 4.57. Based on the General Ledger, advances owed by Sunrise Acquisitions (Keswick) Inc. to Hwy 7 are \$1,259,475.

I. Sunrise Acquisitions (Keswick II) Inc.

- 4.58. Sunrise Acquisitions (Keswick II) Inc. is a single purpose real estate development entity that is part of the Sunrise Homes group.
- 4.59. Based on our review of the Hwy 7 Bank Information, total payments to Sunrise Acquisitions (Keswick II) Inc. was \$290,200 over the Period of Review.
- 4.60. Over the same period, deposits from Sunrise Acquisitions (Keswick II) Inc. were \$8,000.

- 4.61. As a result of the above, Net Payments to Sunrise Acquisitions (Keswick II) Inc. was \$282,200 over the Period of Review.
- 4.62. As detailed in Schedule 9, the Net payments to Sunrise Acquisitions (Keswick II) Inc. over the Period of Review were accounted for as Advances.
- 4.63. Based on the General Ledger, advances owed by Sunrise Acquisitions (Keswick II) Inc. to Hwy 7 are \$282,200.

J. Sunrise Acquisitions (Tisdale) Inc.

- 4.64. Sunrise Acquisitions (Tisdale) Inc. is a single purpose real estate development entity that is part of the Sunrise Homes group.
- 4.65. Based on our review of the Hwy 7 Bank Information, total payments to Sunrise Acquisitions (Tisdale) Inc. were \$281,300 over the Period of Review.
- 4.66. Over the same period, deposits from Sunrise Acquisitions (Tisdale) Inc. were \$0.
- 4.67. As a result of the above, Net Payments to Sunrise Acquisitions (Tisdale) Inc. were \$281,300 over the Period of Review.
- 4.68. As detailed in Schedule 10, the payments to Sunrise Acquisitions (Tisdale) Inc. over the Period of Review were accounted for as Advances as follows:

- 4.69. We are advised that the transaction on November 10, 2015 for \$51,000 should have been accounted for in the Sunrise Acq (Tisdale) Inc. account and represents an error in the General Ledger. Throughout the Period of Review, this is the only transaction in the General Ledger account Sunrise Acq (Hwy 7) Inc.
- 4.70. Accordingly the advances owed by Sunrise Acquisitions (Tisdale) Inc. to Hwy 7 should be \$281,300.

K. Sunrise Acquisitions (Tisdale II) Inc.

- 4.71. Sunrise Acquisitions (Tisdale II) Inc. is a single purpose real estate development entity that is part of the Sunrise Homes group.
- 4.72. Based on our review of the Hwy 7 Bank Information, total payments to Sunrise Acquisitions (Tisdale II) Inc. was \$110,650 over the Period of Review.
- 4.73. Over the same period, deposits from Sunrise Acquisitions (Tisdale II) Inc. were \$30,000.
- 4.74. As a result of the above, Net Payments to Sunrise Acquisitions (Tisdale II) Inc. were \$80,650 over the Period of Review.
- 4.75. As detailed in Schedule 11, the Net Payments to Sunrise Acquisitions (Tisdale II) Inc. over the Period of Review were accounted for as Advances.
- 4.76. Based on the General Ledger, advances owed by Sunrise Acquisitions (Tisdale II) Inc. to Hwy 7 are \$80.650.

L. Sunrise Acquisitions Inc.

- 4.77. Sunrise Acquisitions Inc. is a single purpose real estate development entity that is part of the Sunrise Homes group. We were advised that this entity was involved in a real estate development project in Markham, Ontario.
- 4.78. Based on our review of the Hwy 7 Bank Information, total payments to Sunrise Acquisitions Inc. were \$46,540 over the Period of Review.
- 4.79. Over the same period, deposits from Sunrise Acquisitions Inc. were \$0.
- 4.80. As a result of the above, Net Payments to Sunrise Acquisitions Inc. were \$46,540 over the Period of Review.
- 4.81. As detailed in Schedule 12, the Net Payments to Sunrise Acquisitions Inc. over the Period of Review were accounted for as Advances.
- 4.82. Based on the General Ledger, advances owed by Sunrise Acquisitions Inc. to Hwy 7 are \$46,540.

M. Sunrise Acquisitions (Burlington) Inc.

- 4.83. Sunrise Acquisitions (Burlington) Inc. is a single purpose real estate development entity that is part of the Sunrise Homes group.
- 4.84. Based on our review of the Hwy 7 Bank Information, total payments to Sunrise Acquisitions (Burlington) Inc. was \$300 over the Period of Review.
- 4.85. Over the same period, deposits from Sunrise Acquisitions (Burlington) Inc. were \$0.
- 4.86. As detailed in Schedule 13, the payment to Sunrise Acquisitions (Burlington) Inc. in December 2016 was accounted for as Advances.
- 4.87. Based on the General Ledger, advances owed by Sunrise Acquisitions (Burlington) Inc. to Hwy 7 are \$300.

N. Sunrise Acquisitions (Barrie) Inc.

- 4.88. Sunrise Acquisitions (Barrie) Inc. is a single purpose real estate development entity that is part of the Sunrise Homes group.
- 4.89. Based on our review of the Hwy 7 Bank Statements, total payments to Sunrise Acquisitions (Barrie) Inc. were \$125,500 over the Period of Review.
- 4.90. Over the same period, deposits from Sunrise Acquisitions (Barrie) Inc. were \$215,200.
- 4.91. As a result of the above, Net Deposits from Sunrise Acquisitions (Barrie) Inc. were \$89,700 over the Period of Review.
- 4.92. As detailed in Schedule 14, the Net Deposits over the Period of Review were accounted for as Advances.
- 4.93. Based on the General Ledger, advances owed by Hwy 7 to Sunrise Acquisitions (Barrie) Inc. are \$89,700.

O. Sunrise Acquisitions (Bond Head II) Inc.

4.94. Sunrise Acquisitions (Bond Head II) Inc. is a single purpose real estate development entity that is part of the Sunrise Homes group.

- 4.95. Based on our review of the Hwy 7 Bank Information, there were no payments to Sunrise Acquisitions (Bond Head II) Inc. over the Period of Review.
- 4.96. Over the same period, deposits from Sunrise Acquisitions (Bond Head II) Inc. were \$124,000.
- 4.97. As a result of the above, Net Deposits from Sunrise Acquisitions (Bond Head II) Inc. were \$124,000 over the Period of Review.
- 4.98. As detailed in Schedule 15, the Net Deposits over the Period of Review were accounted for as Advances.
- 4.99. Based on the General Ledger, advances owed by Hwy 7 to Sunrise Acquisitions (Bond Head II) Inc. are \$124,000.

P. Sunrise Acquisitions (Bond Head) Inc.

- 4.100. Sunrise Acquisitions (Bond Head) Inc. is a single purpose real estate development entity that is part of the Sunrise Homes group.
- 4.101. Based on our review of the Hwy 7 Bank Information, total payments to Sunrise Acquisitions (Bond Head) Inc. were \$267,250 over the Period of Review.
- 4.102. Over the same period, deposits from Sunrise Acquisitions (Bond Head) Inc. were \$923,000.

- 4.105. Based on the General Ledger, advances owed by Hwy 7 to Sunrise Acquisitions (Bond Head) Inc. are \$655,750.

Q. IKH Holdings Inc.

- 4.106. IKH Holdings Inc., a related party to Sunrise Acquisitions (Hwy 7) Inc by virtue of its relationship with the Principals, is a management company for Hwy 7.
- 4.107. Based on our review of the Hwy 7 Bank Information, total payments to IKH Holdings Inc. were \$67,450 over the Period of Review.

- 4.108. Over the same period, deposits from IKH Holdings Inc. were \$4,018.
- 4.109. As a result of the above, Net Payments to IKH Holdings Inc. were \$63,432 over the Period of Review.
- 4.110. The Net Payments to IKH Holdings Inc. over the Period of Review were recorded in an account entitled "IKH Holdings Inc.". At year end, the balance of the IKH Holdings Inc. account would be transferred (together with other Related Party accounts) to an account entitled "Intercompany Transactions". The year-end balance of the Intercompany Transactions account matches the balance of the financial statement worksheets and trial balance provided. The balance of the account does not change to account for the transactions as an Other Assets, Expenses or Equity and, therefore, the Net Payments to IKH Holdings Inc. of \$63,342 have been accounted for and categorized as Advances.

R. Amal Financial Inc.

- 4.114. As a result of the above, Net Payments to Amal Financial were \$8,153 over the Period of Review.
- 4.115. The Net Payments to Amal Financial Inc. over the Period of Review were recorded in an account entitled "Amal Financial Inc.". At year end, the balance of the Amal Financial Inc. account would be transferred (together with other Related Party accounts) to an account entitled "Intercompany Transactions". The year-end balance of the Intercompany Transactions account matches the balance of the financial statement worksheets and trial balance provided. The balance of the account does not change to account for the transactions as an Other Assets, Expenses or Equity and, therefore, the Net Payments to Amal Financial Inc. of \$8,153 have been accounted for and categorized as Advances

S. 2303484 Ontario Inc.

- 4.116. 2303484 Ontario Inc. is a related party to Sunrise Acquisitions (Hwy 7) Inc.
- 4.117. Based on our review of the Hwy 7 Bank Information, total payments to 2303484 Ontario Inc. were \$250 on September 20, 2015.

- 4.118. Over the same period, deposits from 2303484 Ontario Inc. were \$0.
- 4.119. As a result of the above, Net Payments to 2303484 Ontario Inc. were \$250.
- 4.120. As detailed in Schedule 19, the payment to 2303484 Ontario Inc. was accounted for as an Advance to 2303484 Ontario Inc.

T. 2356266 Ontario Inc.

- 4.121. We were advised that 2356266 Ontario Inc. is a related party to Sunrise Acquisitions (Hwy 7) Inc. that owns land for development.
- 4.122. Based on our review of the Hwy 7 Bank Information, total payments to 2356266 Ontario Inc. were \$60,050 over the Period of Review.
- 4.123. Over the same period, deposits from 2356266 Ontario Inc. were \$706,200.
- 4.124. As a result of the above, Net Deposits from 2356266 Ontario Inc. were \$646,150 over the Period of Review.
- 4.125. As detailed in Schedule 20, the Net Deposits from 2356266 Ontario Inc. were accounted for as Advances.

U. Differences between the Bank Information and the General Ledger

4.126. There are transactions recorded in the Bank Information that do not appear to have been recorded in the General Ledger. These transactions are summarized below by Principal and Related Party:

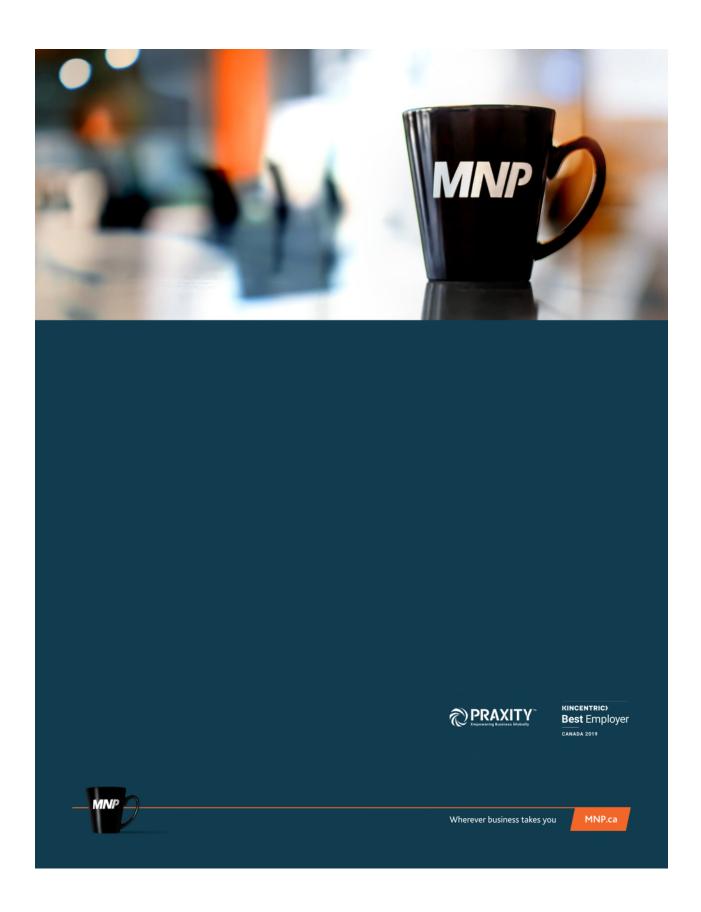
