Notice of Motion Re: Requisition of Shareholder Meeting

2064818 Ontario Inc. ("206 Ontario") and 6138241 Canada Inc. ("613 Canada"), significant shareholders of Unique Broadband Systems Inc. ("UBS"), (the "Moving Parties") will make a motion to a Judge of the Commercial List at 330 University Ave., Toronto, on a date to be established at a 9:00 a.m. case conference with Justice Wilton-Siegel on Wednesday April 25, 2012, at 361 University Avenue, Toronto.

PROPOSED METHOD OF HEARING: Orally

THE MOTION IS FOR:

- 1. an Order that UBS hold a special meeting of shareholders on July 11, 2012, being the meeting date set by UBS in its press release of March 28, 2012 in response to the requisition of 2064818 Ontario Inc. and 6138241 Canada Inc. dated March 8, 2012;
- 2. An order for the costs of this motion plus any applicable taxes there on; and
- 3. Such further and other relief as to this Honourable Court may seem just.

THE GROUNDS FOR THE MOTION ARE:

- 4. On January 18, 206 Ontario announced its intention to make a take-over bid (the "Offer") for up to 10 million common shares of Unique Broadband Systems, Inc. ("UBS").
- 5. The Offer and accompanying circular were mailed to UBS's shareholders on February 1, 2012.
- 6. On March 8, 2012, 206 Ontario and 613 Canada sent a requisition for a special meeting of the shareholders of UBS (the "Requisition") and extended the expiry date of the Offer from March 9, 2012 to May 11, 2012.
- 7. On March 28, 2012, UBS replied to the Requisition by way of letter and press release. In the press release UBS set May 24, 2012 as the record date for an annual and special meeting of UBS's shareholders (the "Requisitioned Meeting"), and July 11, 2012 as the date for the Requisitioned Meeting.
- 8. In its press release UBS has tied the holding of the Requisitioned Meeting to the resolution of the claims process in the CCAA. Among other things, including urging UBS's shareholders to reject the Offer, the March 28 UBS press release states that "UBS, its board of directors and its chairman, reserve the right, in their sole discretion, to either adjourn the Meeting or seek an order of the court to postpone the Meeting, including until such time as the claims process is completed."
- The Fourth Extension and the initial phase of the claims determination process is set out in an order dated April 17, 2012. It is clear that the claims determination process is not going to be completed by July 11, 2012, and will likely not be completed until months later.

- 10. On April 18, 2012 counsel for the Moving Parties wrote to counsel for UBS to seek assurance that UBS would not be seeking an adjournment of the Requisitioned Meeting. By way of letter dated April 19, 2012 UBS advised that it would not give any such assurance.
- 11. UBS is attempting to frustrate the Offer and the holding of the Requisitioned Meeting by reserving the right in its sole discretion, to either adjourn the Requisitioned Meeting or seek an order of the court to postpone the Requisitioned Meeting including until such time as the claims resolution process is completed.
- 12. The foregoing will lead to the Requisitioned Meeting being adjourned indefinitely.
- 13. There is no reason that the Requisitioned Meeting should not proceed on July 11, 2012.
- 14. Rule 37 of the Rules of Civil Procedure, R.R.O. 1990, Reg. 194, as amended.
- 15. Sections 94, 105, 106 and 253 of the *Business Corporations Act* (Ontario), R.S.O. 1990,c. B 16, as amended.
- 16. Such further and other grounds as counsel may advise and this Honourable Court permit.
