KSV Kofman Inc. ("KSV"), in its capacity as the court-appointed monitor (the "Monitor") of the Applicants and the affiliated entities listed on Schedule "A" (collectively, the "CCAA Entities", and each individually a "CCAA Entity"), pursuant to the *Companies' Creditors Arrangement Act*, R.S.C. 1985, c. c-36, as amended (the "CCAA") will make a motion to Senior Regional Justice Morawetz on April 30, 2019 at 8:30 a.m., or as soon thereafter as the motion can be heard, at the Courthouse located at 330 University Avenue, Toronto, Ontario, Canada.

PROPOSED METHOD OF HEARING:

The motion is to be heard orally.

THE MOTION IS FOR AN ORDER:

- 1. if necessary, validating and abridging the time of service of the Notice of Motion and Motion Record and directing that any further service of the Notice of Motion and Motion Record be dispensed with such that this Motion is properly returnable on the date scheduled for the hearing of this Motion;
- 2. declaring that the Monitor shall not provide Guy Gissin, in his capacity as the appointed functionary and foreign representative of Urbancorp Inc. by order of the District Court in Tel Aviv-Yafo, Israel (the "Israeli Functionary"), with copies of the documents requested by the Israeli Functionary pursuant to an email from his Canadian counsel dated March 20, 2019 (the "Document Request"); and
- 3. such further and other relief as counsel may advise and this Court may permit.

THE GROUNDS FOR THE MOTION ARE:

Document Request

- 1. The Document Request was made pursuant to Section 3(d) of the Protocol between the Functionary and the Monitor dated May 13, 2016 (the "**Protocol**") as approved by this Court by the Initial Order made in these proceedings on May 18, 2016 (the "**Initial Order**");
- 2. The Monitor is aware that the Foreign Representative has commenced an action or actions in Israel against Alan Saskin and others in connection with, among

other things, misrepresentations made in the prospectus related to the Israeli bond issuance of Urbancorp Inc. (the "Israeli Actions");

- 3. The Monitor is also aware that many of the documents requested pursuant to the Document Request (the "**Documents**") pertain to matters and parties which are the subject of the Israeli Actions;
- 4. The Documents consist of emails from the former Chief Financial Officer of the Applicants, Mr. Phillip Gales, seeking independent legal advice but are sent from his work email account and often copied to his spouse but no other third party;
- 5. The Monitor is of the view that the Documents are privileged solicitor-client communications and that only Mr. Gales can waive such privilege;
- 6. Section 3(d) Protocol provides that if the Monitor is of the view that information requested by the Monitor is subject to privilege or confidentiality restrictions, then the Monitor shall so inform the Functionary and shall seek directions from the Canadian Court on notice to the affected parties in these proceedings as to whether there are any restrictions which would prevent the disclosure of such information to the Functionary;

Sealing

7. The confidential appendix to the Thirty-Third Report of the Monitor dated April 24, 2019 contains copies of the Documents which the Monitor believes are privileged and confidential to Mr. Gales;

- 8. The Monitor is not aware of any party that would be prejudiced by the proposed sealing of such information;
- 9. There are no reasonable alternative measures to sealing such information from the public record;
- 10. The salutatory effects of sealing such information from the public record greatly outweigh the deleterious effects of doing so under the circumstances;
