#### 1.0 Introduction

- 1. This report (the "Supplemental Report") supplements the jointly titled Monitor's Forty-Third Report to Court and the Receiver's Fifth Report to Court dated November 30, 2020 (the "Sale Approval Report").
- 2. Defined terms in this Supplemental Report have the meaning provided to them in the Sale Approval Report.
- 3. The purpose of this Supplemental Report is to respond to the motion record of King Towns North Inc. ("KTNI") which was served on December 7, 2020 (the "KTNI Motion").

### 2.0 Responses

- 1. The Court Officer responds to the KTNI Motion as follows:
  - a) The Court Officer did not negotiate with KTNI concerning an allocation of the Transaction proceeds as it believes that the issues raised in the KTNI Motion as it relates to amounts owing to it are properly addressed in a distribution motion and not the sale and approval motion. The Court Officer will advise of its position on distribution in the context of a distribution motion. The Court Officer expects that various stakeholders will have a perspective on distributions to KTNI; and
  - b) The Court Officer's negotiations with FCR were in respect of the Encroachment Agreement, which it is a Purchased Asset under the APA. Accordingly, the Court Officer has continued to negotiate with FCR in that regard. This is a non-monetary negotiation affecting access to the boreholes located on the FCR Lands, which is required by any owner of the Fuzion geothermal system.
