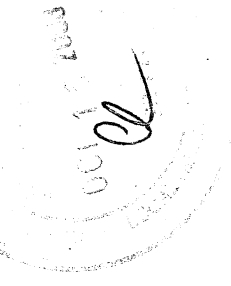
The was no opposite to the Vstg Orders.

Agent with John L. L. L. - the Applicant
advised that the proposed agents remain
in that form. The Trustee has noted in
its Supplement to the 3rd Report. ~~that~~ at
page 5 that it has concerns with the
amount of time that is being spent on
negotiating Accomdat Agents. The
Trustee noted that the Applicant has
been distracted by this issue and
~~that~~ that time spent negotiating these
Agents means less time spent by
the Applicant on the major issue -
pursuing either a sale or a restructuring
of the business. While some progress
has been made in reaching Accomdat
Agents - the parties would be best
served, in my view, if the remaining
proposed Accomdat + Accn Agent
was finalized with JCI and the
Accn Agent was finalized with Lear.
The Trustee is directed to inform JCI
that the Court shares the concerns of
the Trustee. Counsel for Lear was
present in Court so that this
directive relates solely to JCI

The Minister is also directed to file a brief report with the Court on Oct 24/04 the purpose of which is to update the Court on ~~the~~ the progress ~~that~~ + ~~the~~ status of negotiations between the Applicant and JCI and her.

With respect to the report for the extension, there is no doubt that these are difficult times for agencies such as the Applicant and that ~~the situation may take~~ it may take some time for the best solution to present itself. The same process is going on the Applicant continues to search for restructuring alternatives.
