## ENDORSEMENT OF JUSTICE OSBORNE:

[1] Counsel for the parties attended at this case conference today to settle the terms of the order arising from my earlier Endorsement in this matter, and to request that I correct typographical errors in that Endorsement.

[2] My Endorsement was released to the parties on November 22, 2022. That is the date of the Endorsement and should be the date reflected in the Order.

[3] The parties brought to my attention, for which I am grateful, typographical errors in the Endorsement previously released, as follows:

a. the Court file number should begin with a "21" prefix, rather than "22";

b. Mr. Soutter's clients should be defined as "Yonge SL LPs", rather than "Yonge Street LPs"; and

c. the date on which the matter was heard was September 26, 2022, rather than November 7.

[4] I approve the requested amendments to the Endorsement to reflect these typographical errors. There are no substantive changes to the Endorsement or the disposition of the matter. I have attached to this Endorsement a Revised Endorsement of November 22, 2022 reflecting the above typographical corrections.
